Guests in attendance were: In person: Jolly Rose, Adrian Hart, Lex Nichols, Damon Nichols, Darrin Garcia and Danelle Berg. On phone: Marty Lee and Anne Boswell.

Chr. Goodwin called the meeting to order and requested approval of the minutes from September 14th, 2020. Co. Hostetler motioned to approve the minutes. Chr. Goodwin seconded. Motion carried.

Darren Garcia Facilities Project Manager presented bids for painting the Rocky Ford Annex. The bids are for an area of approx. 5000 square feet including 6 office spaces. The contractors were invited for a walk through on September 9th. The bids could be returned by email, fax, delivered by hand, or mailed. There were 8 contractors invited to do the walk through only 5 returned bids. Corsentino Construction \$17,496.00, Lenny's Painting \$10,600.00, Casey Valerio \$13,900.00, Valley Painters \$12,715.94 and Damon 24-7 \$12,000.00. Mr. Garcia asked for a week to take a look at the bids and determine the best way to go. Co. Hostetler motioned to approve a week to look at bids. Chr. Goodwin seconded. Motion carried.

Chr. Goodwin presented the bills from Sept. 1- Sept. 15, 2020, for approval. Co. Hostetler motioned to approve the bills. Chr. Goodwin seconded. Motion carried.

Chr. Goodwin presented a letter for ratification for support of the Protect Our Neighbor status for the counties of Bent, Crowley and Otero. Co. Hostetler motioned to approve the letter. Chr. Goodwin seconded. Motion carried.

Danelle Berg attended an OPI meeting and they now have all the signatures needed to amend the IGA and the bylaws. There has been an upswing in potential new businesses in Otero County and southeast corner of Colorado. Her biggest problem is finding places to put them. She would like the public to know that OPI is not a pass through for the CARES Act, people will need to contact the Commissioner's office about that.

Lex Nichols the Public Works Director presented that the EPA came and did some assessments on two burned houses, one in Rocky Ford and one in La Junta, they were making sure the asbestos was cleared away correctly. The county is looking into approval for a few more houses. Road and Bridge bought a Cat road reclaimer, it works by mulching up the road and they then add material to it to make the road better. Discussion was held.

Co. Hostetler attended the OPI meeting and the OCLI Board meetings. Danny Chavez will be leaving as landfill manager to focus fulltime on being the Emergency Management. Co. Hostetler attended a Sage meeting and they are having discussions on the HVAC system.

Chr. Goodwin presented that he along with the Commissioners doing the budget hearings with all the department heads. He is happy that everyone is trying to be as efficient as possible. He discussed the Tabor Blue book, he would like people to actually read and be informed of what they are voting for.

With no further business, the board adjourned the meeting.



RE: Letter of Support - National Park Designation - Amache Internment Camp

Dear Review Panel,

The Otero County Board of County Commissioners would like to express our absolute support for the development and designation of the Grenada Relocation Center, also known as the Amache Internment Camp, in becoming a new unit of the National Park System. We strongly believe this historic site in our neighboring county of Prowers meets the criteria for designation and that the National Park System can create space for all Americans and visitors to America to honorably remember the internment of Japanese Americans.

Various traits differentiate Amache from other Japanese American incarceration camps throughout the US. Amache had the highest rate of service of all the camps: a total of 953 men and woman from Amache volunteered or were drafted for military service during WWII, nearly 10 percent of all people at the camp. (amache.org) In addition, its agricultural production was exceptionally successful, growing enough food to feed the entire camp population and send surplus to the US Army and other camps. In 1943 alone, Granada farmers grew 4 million pounds of vegetables. (Amache Preservation Society, "Agriculture at Amache"). Amache also had a host of notable internees, including Chiyoko Sakamoto, California's first Japanese American female lawyer, Robert S. Hamada, the Edward Eagle Brown Distinguished Service Professor of Finance Emeritus at the University of Chicago Booth School of Business and former dean of Chicago Booth, and Sam Saburo Teresaki and Kiyoshi K. Muranaga, two decorated soldiers in the US Army. Additional activities that internees developed to cope with their new normal included the Amache Silkscreen Shop, a Boy Scout Troop, a community newspaper, and various adult education classes.

With the care and management of the National Park Service, Amache can reach its full potential as a National Park. In its current state, Amache is a bare, uninviting place that hardly depicts the actuality of the individuals and families that were uprooted and, against all odds, established new lives there. In Otero County's vision, Grenada Relocation Center would be an accessible place for local students, educators, and touring visitors alike to have the opportunity to tangibly experience and understand life for Japanese Americans at Amache internment camp through interactive learning stations, large photo displays, and detailed biographies of notable internees.



We believe it is important to preserve and designate this historical site to acknowledge the 10,000 Japanese Americans who were wrongfully incarcerated and passed through this internment camp in its three-year existence, and to honor the brave internees who fought and died for our country when they were called to duty. It is also an especially critical duty, considering our current political climate, to look to America's past and collectively recognize our mistakes to learn from them and make informed and compassionate future decisions. Recognizing this site as a National Park would communicate to all Americans and visitors to our country that we will not lose sight of the gravity of the internment of Japanese Americans.

Thank you for conducting the special resource study and for considering Grenada Relocation Center as a new unit of the National Park System. We look forward to the possibility of having such an important part of our local and national history recognized and honored with the assistance of the National Park Service.
