Chr. Oquist asked everyone to stand for prayer and to recite the Pledge of Allegiance.

Chr. Oquist called the regular meeting to order.

Chr. Oquist called for approval of the consent agenda. The agenda includes approval of the minutes from December 18<sup>th</sup>, and December 21<sup>st</sup>, 2023, bills, and payroll for December 16<sup>th</sup> to December 31<sup>st</sup>, 2023. The consent agenda also includes the Otero County Housing Authority Appointment, Ambulance Permits for The La Junta Rural Fire, Fowler Rural Fire District, and the Rocky Ford Emergency Medical Services and the application approval for the People Who Wander Grant. Co. Baldwin motioned to approve the consent agenda. Co. Knabenshue seconded. Motion carried.
