Chr. Goodwin called the meeting to order and to approve the minutes from January 13th, 2020. Co. Hostetler motioned to approve the minutes with corrections. Co. Baldwin seconded. Motion carried.

Sharon Jones presented the Semi Annual Report of Otero County Treasurer, total ending funds for 2019 are \$17,617,769.96. Discussion was held.

Bruce Fickenscher presented the CSU Extension Quarterly Report. He was happy to report they are finally moved into new office. Discussion was held.
