Chr. Oquist asked everyone to stand for Prayer and the Pledge of Allegiance.

Chr. Oquist called the regular meeting to order.

Chr. Oquist called for approval of the consent agenda. The agenda includes approval of the minutes from September 8th, 2025, bills and payroll for September 1st through September 15th, 2025, and the Financial Report Ending July 31, 2025, for the Department of Human Services. Co. Baldwin motioned to approve the consent agenda. Co. Knabenshue seconded. Motion carried.

Teale Hemphill, with the Southeast Colorado Regional Housing Authority, presented an update on the development fund that has received grant money to purchase land for homes throughout the Six (6) County Region. They are at present looking to purchase properties owned by Municipalities or from private owners. The grants can be used to build new homes or to renovate existing homes. In 2026, there are plans to build several 3-bedroom, 3 bath and 2 bedroom, 2 bath homes. Co. Knabenshue motioned to approve \$226,666.29 for the Southeast Colorado Regional Housing Authority. Co. Baldwin seconded. Motion carried.

Co. Knabenshue presented the Memorandum of Understanding (MOU) between Southeastern Colorado Water Conservancy District, Otero County, the Colorado Water Conservation Board, and Colorado Water Resources and Power Development Authority. The purpose of the MOU is to establish a framework for the joint efforts of the parties to utilize state and federal monies through loans or grant funds to help with portions of the Arkansas Valley Conduit. Co. Knabenshue motioned to approve the MOU. Co. Baldwin seconded. Motion carried.

Clerk Scott presented a special liquor license for the Arkansas Valley CASA, Boots 'n Bling event to be held in October 2025. Co. Knabenshue motioned to approve the license. Co. Baldwin seconded. Motion carried.

Co. Baldwin presented the Sales Tax Report. There is a 1% cumulative change in revenue from last month and a 3% change in revenue from this time last year. The county is doing well.

Clerk Scott reported that her office will be conducting Logic and Accuracy testing (LAT's) on October 9th, 2025, to test the machines prior to election day.

Co. Baldwin reported that he attended The Arkansas Valley Water Roundtable meeting, they talked about grant applications for drinking water systems. There will be about \$150,000.00 available for the grants. The application period closes on the 21st of October they will be awarding them in November 2025 for 2026.

Chr. Oquist and Co. Knabenshue attended several of the same meetings. Ones of note were Colorado Counties Incorporated (CCI), Colorado Department of Transportation (CDOT), The Lower Arkansas Valley Water District, Otero County Landfill Incorporated (OCLI), and the Conduit meeting. Chr. Oquist also attended a meeting for Region Six Alcohol and Drug Abuse, CO. (RESADA). They are adding a new building to the campus and Chr. Oquist is impressed by the programs being offered.
