Guests in attendance in person: Anne Boswell, Jon Saunders, Chad Penner, Bette McFarren, Adrian Hart, Lex Nichols, and Sharon Jones.

Chr. Oquist asked everyone to stand for prayer and to recite the Pledge of Allegiance.

Chr. Oquist called the regular meeting to order.

Jon Saunders with SECOM presented news of the State of Broadband Expansion. This would expand fiber from Cheraw to the Bent County line.

Chr. Oquist called for approval of the consent agenda. The agenda includes approval of the minutes from January 8th, 2024, bills, and payroll for January 1st to January 15, 2024. The consent agenda also includes the Emergency Management Performance Grant Application, Cheraw Drainage District Board Appointments, Rocky Ford Emergency Medical Services, Ambulance Permit, and Financial Statements-General Human Services. Co. Knabenshue motioned to approve. Co. Baldwin seconded. Motion carried.

Sharon Jones announced Tax Roll was balanced and sent to mail. Jones gave the Public Trustee Report and the Semi-Annual Report. Commissioners requested Jones to investigate interest rates to see if the County could move money to higher interest rate accounts/cd's. Co Baldwin motioned to approve the Public Trustee Report and Semi-Annual Report. Co Knabenshue seconded. Motion carried.

Lex Nichols spoke about the Highway User Tax Fund Year End Report. Nichols stated there were no changes in 2023. The County still covers the same number of miles. Nichols requested signatures on the report. Chr. Baldwin motioned to approve the year-end report. Co. Baldwin seconded. Motion carried.

Holly Huerta-Hudak talked about affiliation cut off dates for the Presidential Primary Election. She described the difference between the No Label minor party and Unaffiliated. Huerta-Hudak also spoke about the affiliation cutoff date for the Democratic and Republican Caucus.

Admin. Amy White-Tanabe gave the sales tax report. White-Tanabe said the Commissioner's Office is looking forward to and gearing up for new legislation.

Co Knabenshue attended the Southeast Colorado Business Retention Expansion and Attraction (SEBREA), Otero Partners Incorporated (OPI), and construction meetings, and met the new director at the Colorado Counties Incorporated (CCI) meetings.

Resolution #2024-05

APPROVING AN AGREEENT BETWEEN CROWLEY COUNTY, COLORADO AND OTERO COUNTY, COLORADO, ESTABLISHING THE EUREKA WATER AUTHORITY TO BE LOCATED IN OTERO COUNTY

WHEREAS, Crowley County and Otero County are each duly and regularly created, organized and existing political subdivisions and public bodies corporate of the State of Colorado; and

WHEREAS, Crowley County and Otero County are authorized by the provisions of Colo. Const. Art. XIV, §18, and C.R.S. 29-1-201, *et seq.*, to enter into contracts with other political subdivisions of the State of Colorado; and

WHEREAS, Crowley County and Otero County are authorized by the provision of C.R.S. §29-1-204.2 to establish a water authority to be used to effect the development of water resources, systems and facilities, in whole or in part, for the benefit of the inhabitants and service users of the contracting parties or others at the discretion of the board of directors of the authority; and

WHEREAS, in order for the Eureka Water Company to obtain federal grants and low interest rate loans from the Colorado Water Resources and Power Development Authority, Eureka Water Company is required to be organized as a local government for state law purposes; and

WHEREAS, in order to become organized as a local government, Eureka Water Company approached Otero and Crowley Counties requesting that they form a water authority pursuant to their statutory powers to better serve the residents and rate payers of the Eureka Water Company system; and

WHEREAS, the Eureka Water Company has entered into a legal agreement to transfer any/all ownership of its assets to a Water Authority; and

WHEREAS, without the legal transfer of assets within thirty (30) days of the formation of the Water Authority shall dissolve the Water Authority; and

WHEREAS, there has been presented to the Boards of County Commissioners of Crowley County and Otero County (the "Board") the form of Establishing Contract for the Eureka Water Authority; and

WHEREAS, Crowley County and Otero County have determined it is in the best interests of their constituents and service users to establish a water authority to be known as the Eureka Water Authority to provide water service within portions of Otero County to the current Eureka Water Company Users.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF CROWLEY COUNTY, COLORADO (THE "BOARD"):

Section 1) Approval of Establishing Contract and Ratification and Approval of Prior Actions. The Board of County Commissioners hereby approves the Eureka Water Authority Establishing Contract in the form presented at this meeting. All action heretofore taken (not inconsistent with the provisions of this resolution) by the Board, or the officers or agents of the Board or the County, relating to the formation of the Eureka Water Authority is hereby ratified, approved and confirmed.

Section 2) <u>Findings Relating to the Eureka Water Authority</u>. The Board hereby finds and determines that pursuant to Section 29-1-204.2, C.R.S., the creation of the Eureka Water Authority is necessary for the development of water resources, systems, or facilities or of drainage facilities in whole or in part for the benefit of the inhabitants of Otero County and Crowley County.

Section 3) Finding of Best Interests. The Board hereby finds and determines the creation of the Eureka Water Authority is necessary, convenient and in furtherance of the County's purposes and is in the best interests of the inhabitants of the County; and the Board hereby authorizes and approves such creation.

Section 4) <u>Authorization to Execute Collateral Documents</u>. Any member of the Board of County Commissioners, the County Administrator, or other appropriate officials or agents of the Board or the County, are hereby authorized to execute and deliver for and on behalf of the County any and all additional certificates, documents, instruments and other papers, and to perform all other acts that they may deem necessary or appropriate, in order to implement and carry out the transactions and other matters authorized by this resolution, including but not limited to the execution of the Eureka Water Authority Establishing Contract and such other documents, certificates and affidavits as may be necessary. The execution of any instrument by the aforementioned officers or members of the Board shall be conclusive evidence of the approval by the Board of such instrument in accordance with the terms hereof and thereof.

Section 5) Repealer. All bylaws, orders and resolutions of the Board, or parts thereof, inconsistent with this resolution or with the Eureka Water Authority Establishing Contract hereby approved, are hereby repealed only to the extent of such inconsistency. This repealer shall not be construed as reviving any bylaw, order or resolution of the District, or part thereof, heretofore repealed.

Section 6) No Financial Commitment. The County shall not provide, nor be asked to provide, any financial, technical, and/or legal support to the Water Authority. The Water Authority shall be solely responsible for all financing, designing, constructing, acquiring, operating, maintaining and utilizing water resources, facilities and services.

Section 7) No Indebtedness. Any/all bonds, notes or other obligations shall be entirely and without equivocation the sole responsibility of the Water Authority.

Section 8) <u>Sunshine Laws</u>. The Water Authority, acting as a political subdivision of the state, shall adhere to any/all Sunshine laws (Colorado Open Record Act and the Colorado Open Meeting Law), as well as the Colorado Budget Act, and shall be able to contract with private persons, associations, or corporations for the provision of any legally authorized functions, services, or facilities within or without its boundaries.

Section 9) <u>Proof of Training</u>. Within thirty (30) days of this Resolution, the Board of the Water Authority may provide written confirmation to the County that each Board member has attended the required New Board Member training on the Open Meeting Law, the Colorado Open Records Act, and the Colorado Budget Act.

Section 10) <u>Dissolution of Water Authority</u>. All assets, except bonds, notes, debts, liabilities or obligations of the existing Eureka Water Company shall be transferred to the Authority upon execution of the Agreement, or no later than thirty (30) calendar days from the execution of the Agreement. The Water Authority shall immediately dissolve and the Construction Document(s) shall no longer be in any force or effect without the timely transfer of assets.

Section 11) <u>Effective Date.</u> This resolution shall be in full force and effect upon its passage and adoption.


