Guests in attendance in person: Adrian Hart, Bette McFarren, and Sharon Jones.

Guests in attendance on zoom: Anne Boswell.

Chr. Oquist called the regular meeting to order.

Chr. Oquist asked for public comment.

Chr. Oquist called for approval of the consent agenda. The agenda includes approval of the minutes from January 23rd, 2023, and bills and payroll for January 16<sup>th</sup> to January 31<sup>st</sup>, 2023. Co. Baldwin motioned to approve the consent agenda. Co. Knabenshue seconded. Motion carried.

Clerk Scott presented for ratification a festival liquor license for J & M Liquor out of Rocky Ford, CO. The event was held at the Valley Trading Post; event was a dance that was held from 7pm to 12pm on 2/10/2023. J & M Liquor was providing drinks and security which included 3 security officers on premises and wristbands to show age. Co. Baldwin motioned to approve ratifying the liquor license. Co. Knabenshue seconded. Motion carried.

Clerk Scott presented for approval a tobacco retail license renewal from Bauserman's Market. Co. Baldwin motioned to approve the tobacco license. Co. Knabenshue seconded. Motion carried.

Admin. White-Tanabe presented an Intergovernmental Agreement between the County and the Southeastern Colorado Water Conservancy District.

This is amending the previous IGA dated March 30, 2022, adding \$20,000,000 to the grant funding on the Arkansas Valley Conduit spur. Co. Knabenshue motioned to approve the amended IGA. Co. Baldwin seconded. Motion carried.

Admin. White-Tanabe presented a letter to appoint Ashley Jo Kelley to the Otero County Historic Preservation Board. This is a term of 3 years from January 2023 to December 2025. Co. Baldwin motioned to approve the appointment. Co. Knabenshue seconded. Motion carried.

Admin. White-Tanabe presented a letter to the Otero County Housing Authority to reappoint Darren Garcia to the Board for a 5-year term, beginning on February 1, 2023. Co. Knabenshue motioned to approve the appointment. Co. Baldwin seconded. Motion carried.

Admin. White-Tanabe presented an IGA between the Otero County and Bent County for ratification for the use of Bent County's detention center. Bent County will house 35 inmates for \$766,000 as per agreement. Inmates over that limit will be billed at \$60.00 a day. Co. Baldwin motioned to approve ratifying the IGA. Co. Knabenshue seconded. Motion carried.

Admin. White-Tanabe presented an agreement between the County and TechnologyWest, LLC. The agreement is to put in new security cameras for the clerk's office for elections. There was a grant for a portion of the amount of \$16,050.00. Co. Knabenshue motioned to approve the agreement. Co. Baldwin seconded. Motion carried.

Admin. White-Tanabe presented an agreement between the County and WYOIT. This is to replace security cameras in the courthouse and at the DHS annex on Raton Ave. This will be \$72,909.00 paid completely by grant. Co. Baldwin motioned to approve. Co. Knabenshue seconded. Motion carried.

Admin. White-Tanabe presented a grant through the Colorado Bureau of Investigations that would help the Sheriff's office with equipment to help with search and rescue of people with a diminished capacity. Admin. White-Tanabe is asking for approval to apply for the grant. The amount is approximately \$4,000.00. Co. Knabenshue motioned to approve. Co. Baldwin seconded. Motion carried.

Treasurer Sharon Jones presented the semi-annual Treasurers report. This report is from July 2022 to December 2022. Grand total amount is \$41,060,985.19. Ms. Jones also gave the public trustee report. There were 112 releases for \$1,680.00 and a total of 7 new foreclosures for a total of \$1,050.00. She was asked about the rate of return on the CDs with Colorado Bank and Trust it is approximately 3%. Co. Knabenshue motioned to approve the reports. Co. Baldwin seconded. Motion carried.

Admin. White-Tanabe announced that the county received a grant for \$52,212.00 to help provide mental health support to law enforcement as a partnership program.

Co. Knabenshue reported that he attended a TPR meeting in Lamar. He also attended a meeting about the County 18/Hwy 50 intersection project. That may start up in April or May of this year. He also attended a meeting at Bent's Fort concerning the trail project and its feasibility. Lastly, he attended a water meeting concerning the conduit.

Co. Baldwin reported that he attended Ark Valley Conduit meeting, to organize the board. He also attended the construction conference on the detention center, concerning kitchen appliances and meals. He also attended the Ark Valley River basin meeting.

Chr. Oquist reported that he attended most of the meetings with the other commissioners. He was especially interested in the jail detention center as they are now looking at security cameras, kitchen equipment, and rooms.

With no further business the Board adjourned the meeting

Dear Commissioner Buxton-Andrade,

On behalf of Otero County, we would like to appoint Commissioner Rob Oquist to the Southeast Colorado Opioid Response Settlement Region. We understand from the Bylaws that Otero will have one vote. 
