Guests in attendance were: Dee Leyba, Myra Pacheco, Ashley Paugh, Dave Williams, Jolly Rose, M. Lee, Danelle Berg, Kristina Lofing, Christian Burney, Duane Gurule, and Anne Boswell.

Chr. Pro-Tem Baldwin called the meeting to order and requested to approve the minutes from February 18, 2020, with the following corrections: paragraph 7 first sentence the name Terry should be corrected to Tara, in the same paragraph second sentence, meet needs to be corrected to met. Co. Hostetler motioned to approve the minutes. Co. Baldwin seconded. Motion carried.

Ashley Paugh with Kids Crossing wanted to let the Commissioners know that they are now open. This is a non-profit organization. They are located at the Town Square Mall in La Junta. They are therapy based for children and families in need. Their mission is to strengthen families and nurture children and youth entrusted to them. They are also trauma based. Some of the services will include: Individual therapy, trauma-focused cognitive behavioral therapy, family therapy, and Home/Community based services. There will be a grand opening on March 18th, 2020. Discussion was held.

Dee Leyba presented a report on the increase of suicide rates of teens in Colorado. The suicide rates in 2016 in the Southeast region doubled to 21.4% and in 2018 it increased to 25.9%. There will be a health and wellness community outreach event at the La Junta Primary school from 8:00 A.M- 4:00 P.M. on the 6th of March. Discussion was held.

Admin. White-Tanabe presented a Letter of Support to Tim Stroh with the State Historical Fund for the rehabilitation of the Masonic Lodge where the 16th Judicial District Attorney's office is currently. Co. Hostetler motioned to approve signature on the letter of support. Co. Baldwin seconded. Motion carried.

Admin. White-Tanabe presented a Proclamation for the week of March 29 to April 4, 2020 as Census Response Week. This week will be dedicated to educating residents on how the count will benefit us, encourage residents to fill out the census, and to engage residents by coordinating with the Otero County Census Committee for opportunities on why the census is important. Co. Hostetler motioned to approve the Proclamation. Co. Baldwin seconded. Motion carried.

Danelle Berg reported that she had a busy week. The Southeast Council Government mini grant applications were due. The grants will be reviewed next week and Otero County should get 3. There was a Tourism Board meeting, we are now The Canyon and Plains Tourism Region. The border lines are fuzzy because tourism goes into all regions. Attended SEBREA and they talked about the Prison issue as well as the transmission study on the transmission lines and renewable energy.

Admin. White-Tanabe reported that she attended the Wellness meeting with about 20 staff members. It was an interesting meeting and felt it was very beneficial.

Co. Hostetler reported that he attended a CDOT meeting concerning the passing lanes between Manzanola and Fowler, the starting date is March 16th, 2020. He also attended the SEBREA meeting as well as the Sage meeting, both meeting went well. He attended the Wellness meeting and felt that is was a great meeting. He sat in on the CCI call concerning the lobbyists and grazing in Colorado. Attended the Lincoln day dinner and had a fun time. While he was there, he met with Richard Holtorf of District 64.
