Guests in attendance via phone/zoom: Adrian Hart, Marty Lee, and Anne Boswell. In Person: Danny Chavez and Dee Hostetler.

Chr. Baldwin called the meeting to order and asked for approval of the minutes from February 8, 2021. Co. Oquist motioned to approve the minutes with corrections. Chr. Baldwin seconded. Motion carried.

Dee Hostetler with Clean Valley Recycling presented a letter of support she is asking for signature on. This is for a grant from the Resource Recovery & Economic Opportunity Grant Program. With the implementation of the "Otero County Recycling Challenge" there is the possibility of a 20% increase in recycling, the pilot program will begin on August 1st, 2021. If the increase could be done there is a monetary award of \$50,000.00. They would like to get all 7 Cities/Towns included in this program. Co. Oquist motioned to approve signing the letter of support. Chr. Baldwin seconded. Motion carried.

Otero County Emergency Manager Danny Chavez presented a Regional All Hazards Mutual Aid Agreement. Mr. Chavez is asking for signature on the agreement. All 6 counties in our region are included in this agreement. This takes care of all hazards and the response needed. Co. Oquist motioned to approve signature. Chr. Baldwin seconded. Motion carried.

Admin. White-Tanabe presented the bills and payroll for February 1st to February 15th, 2021. Co Oquist motioned to approve the bills and payroll. Chr. Baldwin seconded. Motion carried.

Admin. White-Tanabe presented the Sales Tax Report for the year ending December 2020. Cumulative % of change is 13.61. The monthly change is 26.38%. The total amount at the end of the year was \$2,174,680.46.

Admin. White-Tanabe said that the highlight of her week was getting the RMMI program for automation of accounts payable implemented. This will be more efficient and easier to use. She wanted to thank Tina Mascarenas for helping to set that up.

Co. Oquist attended a SEBREA meeting, they talked about the Corona virus situation. He also had a SAGE meeting; they should be getting new bags to help keep the meals warm until they get to who they are delivering to. He met with the Clerk's office to see what goes on in the office and to meet with everyone, he said he enjoyed meeting everyone.

Chr. Baldwin presented that he had a meeting with CDOT about greenhouse gases and how they affect the State. They would like to have more electric vehicles on the road by 2025 and approximately 50% by 2030.

Resolution #2021 – 04

A RESOLUTION RECOGNIZING THE MANY PAST AND CURRENT CONTRIBUTIONS OF OTERO COUNTY CATTLEMEN AND OTHER LIVESTOCK PRODUCERS AND SUPPORTING THE LOCAL RANCHING INDUSTRY

WHEREAS, the Governor of Colorado has proclaimed a boycott of meat products, referred to as a "MeatOut" - to promote meatless diets as promoted by the *Farm Animal Rights Movement* (FARM), to be observed by Coloradans on March 20, 2021; and

WHEREAS, cattle and other livestock production has historically been, and continues to be, one of the key economic drivers in Otero County; and

WHEREAS, the Board of County Commissioners found, at the time of the adoption of the Otero County Land Use Code, that "...ranching, farming and all manner of agricultural activities and operations throughout Otero County are integral elements of and necessary for the continued vitality of the County's history, economy, landscape, lifestyle and culture"; and

WHEREAS, Otero County cattlemen, livestock producers and our ranching families are a fundamental part of a \$3.4B state industry with a \$40B economic impact and account for 15% of the States total export sales; and

WHEREAS, the U.S. Department of Agriculture reports that in 2017 the annual sale value of Otero County cattle, calves, poultry, sheep and hogs surpassed \$90M; and

WHEREAS, employment in the agriculture sector and related industries provides jobs to Otero County citizens, a very large number of which are involved in ranching and livestock production; and

WHEREAS, the 2020-2025 Dietary Guidelines issued by the U.S. Food and Drug Administration recognize that a variety of animal and plant proteins is important to a healthy diet; and

WHEREAS, Otero County is a declared "Right to Farm" county and has taken regulatory steps to protect our active farms and ranches.

THEREFORE, BE IT RESOLVED, THAT THE BOARD OF COUNTY COMMISSIONERS OF OTERO COUNTY, COLORADO affirms its support and appreciation for our hardworking cattlemen, farmers and other livestock producers and proclaims March 20, 2021, as Otero County Ranching, Livestock and Meat-IN Day; and

BE IT FURTHER RESOLVED THAT THE BOARD OF COUNTY COMMISSIONERS OF OTERO COUNTY, COLORADO, expresses its displeasure that the Governor of Colorado would call for a boycott, even of a one-day duration, of an industry that is key and essential to both our local and state economy.
