Chr. Oquist called the regular meeting to order.

Chr. Oquist asked everyone to stand and recite the Pledge of Allegiance.

Chr. Oquist called for approval of the consent agenda. The agenda includes approval of the minutes from March 13th, 2023, and bills and payroll for March 15th, 2023. Co. Baldwin motioned to approve the consent agenda. Co. Knabenshue seconded. Motion carried.

Admin. White-Tanabe presented Resolution 2023-07. This resolution is amending resolution 2023-06 and adopting the Otero County Information Security Policy. There was a scriber's error. Co. Knabenshue motioned to approve. Co. Baldwin seconded. Motion carried.

Admin. White-Tanabe presented the FY 2023 EIAF Tier I/Tier II Grant Application Approval- Detention Center Phase III. Admin. White-Tanabe is asking for approval to apply for the DOLA grant. The grant amount could be up to one million and would be 50% of the construction. Co. Baldwin approved the grant application. Co. Knabenshue seconded. Motion carried.

Judges Mark MacDonnell and Sam Vigil, with the 16th Judicial District, Magistrate Rodney Fouracre, and Tobin Wright with Probation, came to thank the commissioners for the single entry into the courthouse. There was a lot of discussion on the single entry and the need for it, when in the planning stages. The courthouse now also has a Magistrates' courtroom and Mr. Fouracre voiced his appreciation for how well it turned out. It is small enough that it is not overwhelming and makes it easier. Mr. Wright also wanted to thank the commissioners on behalf of his staff for a job well done.

The Commissioners returned the compliments to the Judges and other staff for working with them to make the project easier to complete.

Admin. White-Tanabe presented the sales tax report. For the month of December 2022, we collected 235 thousand with a 9% increase from 2021. With a total of 3% cumulative. For the month of January 2023, we collected 189 thousand which is 3.6% more than this time last year.

All the Commissioners attended several meetings. Construction meetings on the detention center, security meetings for the courthouse. Co. Knabenshue attended an emergency management meeting in Fowler, CO., OCLI meetings and SCEDD for enterprise development in the region. Chr. Oquist along with Admin. White-Tanabe attended RESADA meetings that included Southeast Mental Health, which helps with drug and alcohol use.
