Guests in attendance were: In person: Jolly Rose, Rick Ritter, Danelle Berg, Stephen Anderson, Donna Rohde and Dennis Smith. On phone: Anne Boswell, Sheriff Mobley, Marty Lee, Christian Burney.

Chr. Goodwin called the meeting to order and requested approval of the minutes from June 1st, 2020. Co. Baldwin motioned to approve the minutes. Co. Hostetler seconded. Motion carried.

Stephen Anderson a pastor from Fowler, called attention to the variance put in place for Otero, Crowley and Bent Counties, he feels that it still puts an unfair restriction on worshippers and is overly restrictive to residents in the tri-county area. His specific objections are to only 50 persons in a building or the 50% capacity rule and that masks have to be worn.

County Treasurer Dennis Smith gave the Public Trustee report. For the 1st quarter of the year there were 143 release deeds of trust and 6 new foreclosures. The total income was \$5,926.15, the total expenses were the same, Treasurer Smith reported that tax collections have been up by 5% from this time last year, but because of the COVID-19 interest rates have dropped. Discussion was held.

Danelle Berg presented a letter to the Commissioners for signature to the Colorado Office of Economic Development and International Trade. The letter has to do with additional CDBG funding, for Otero and Las Animas Counties' Business Loan Fund. The amount being asked for is \$80,874.00 with 10% or \$8,087.40 being held for administrative expenses. The monies will be primarily used for COVID-19 recovery. Co. Hostetler motioned to approve signature on the letter. Co. Baldwin seconded. Motion carried.

Sheriff Mobley reported that the fire danger in our area is very high. He will be meeting with emergency management and the fire chiefs in the area to discuss how to move forward. There is an outdoor celebration being planned to show appreciation to the hard working deputies at the Sheriff's Office. Chr. Goodwin wanted Sheriff to know that the Commissioners commend his staff for their hard work.

Danelle Berg reported that she was working on 3 microloans in Las Animas County. There is still \$1,000.00 grants available and there is about \$12,000.00 in the fund that can be given out for businesses in Otero County. The 6 county economic developers are looking at the document for COVID recovery. They have gotten through the milestones and each county is now adding a resource list specific to their county. There are 17 more conservation easements that she is working on and she is hoping to have them done by July.

Donna Rohde has been watching the bill list from State Legislature. There are several being introduced that will affect her department. She has also started working on her budget as she has 3 different fiscal years to account for.

Health Department Director Rick Ritter presented that he is working on a second variance, he will be looking at lifting some of the restrictions for fairs and festivals, performing arts and the Koshare's and several others. He will be getting together will the 3 counties, the health departments, the hospitals. If this is favorable it will go into effect hopefully by 7/1/2020. The State cuts to the budget have already started. It will be case by case.

Clerk Scott reported that the LAT test performed on Thursday was a success, and we are ready for Election Day. The Clerk's office will be closed for all business but elections on June 30th.

Admin. White-Tanabe reported that she enjoyed working on the CARES act the most this week. On Friday she met with area administrators and DOLA on how to spend \$1,400,000 for COVID-19 recovery. All monies have to be spent by December 31, 2020. Admin. White-Tanabe thanked Danelle Berg for all of the hard work with DOLA.

Co. Baldwin reported on the walk-through he along with the other commissioners did on the extension building in Rocky Ford. He sat in on the listening tour of the Colorado water plan. This was an introduction to how the plan functions. There will be 2 more listening tours one on agriculture and one on recreation and the great outdoors.

Co. Hostetler sat in on the CCI legislative calls, a lot of bills were discussed during the calls, ones they wanted to move forward and others that they are monitoring.

Chr. Goodwin talked about the ballot issue on de-Gallagherization, that will be on the November ballot. This can ultimately hurt the County because it will cause a possible \$400,000 dollar loss to the general fund. This will affect small counties the most, as we will have to cut services that will no longer be funded.

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is entered into this _____ day of , 2020, by and between the following parties:

- 1. The Board of County Commissioners of Otero County, Colorado, a body politic and corporate, hereinafter referred to as "Otero County";
- 2. The Town of Cheraw, a statutory municipal corporation, hereinafter referred to as "Cheraw";
- 3. The Town of Fowler, a statutory municipal corporation, hereinafter referred to as "Fowler".
- The City of La Junta, a home rule municipal corporation, hereinafter referred to as "La Junta":
- 5. The Town of Manzanola, a statutory municipal corporation, hereinafter referred to as "Manzanola";
- 6. The City of Rocky Ford, a statutory municipal corporation, hereinafter referred to as "Rocky Ford";
- 7. The Town of Swink, a statutory municipal corporation, hereinafter referred to as "Swink":

WHEREAS, through the Coronavirus Relief Fund, the CARES Act provides for payments to State, Local and Tribal governments navigating the impact of the COVID-19 outbreak; and

WHEREAS, the County of Otero and the above-referenced municipalities may receive funds from the United States Treasury's Coronavirus Relief Fund; and

WHEREAS, this agreement is to provide an understanding on the manner in which Otero County and the above-referenced municipalities shall allocate the \$1,568,017.00 in funding that has been made available for the above-mentioned parties.

NOW THEREFORE, in consideration of their mutual promises to each, stated below, the parties hereto agree as follows:

- 1. Due to the restrictive nature in which these funds may be spent, spending authority will be delegated to a committee with a representative from each above-stated body.
- 2. In order to ensure compliance with the State and Federal guidance, the Otero County Attorney will chair and oversee all committee functions.
- 3. Each political subdivision will empower an elected or appointed official to represent its body on the committee. The representative shall have the sole power to sign agreements on behalf of its respective political body.

- 4. Otero County and each municipality will present a list of expenses to the Otero County Attorney for which each body desires to receive funding from the CARES Act.
- 5. The goal of the committee will be to allocate funding on a per capita basis for each political body, with the overall understanding that each party desires to keep the entire allocation within the boundaries of incorporated and unincorporated Otero County.
- 6. Each political subdivision will provide a resolution or properly recorded minutes indicating the name and contact information of its respective representative, with an indication that the named representative has been granted the authority to bind its body.
- 7. The parties agree that the effective date of this agreement shall be the 6th day of July, 2020.

This Memorandum of Understanding may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

A RESOLUTION OF THE OTERO COUNTY BOARD OF COUNTY COMMISSIONERS APPOINTING A REPRESENTATIVE TO SERVE ON A COMMITTEE TO DETERMINE THE ALLOCATION OF FUNDS RECEIVED FROM THE UNITED STATES TREASURY'S CORONAVIRUS RELIEF FUND.

WHEREAS, through the Coronavirus Relief Fund, the CARES Act provides for payments to State, Local and Tribal governments navigating the impact of the COVID-19 outbreak; and

WHEREAS, the County of Otero and the above-referenced municipalities may receive funds from the United States Treasury's Coronavirus Relief Fund; and

WHEREAS, Otero County, the Town of Cheraw, the Town of Fowler, the City of La Junta, the Town of Manzanola, the City of Rocky Ford and the Town of Swink have entered into a Memorandum of Understanding (MOU) to provide an understanding on the manner in which Otero County and said municipalities shall allocate the monies delegated to Otero County and said municipalities, i.e., \$1,568,017.00; and

WHEREAS, pursuant to said MOU, a committee shall be formed to determine the allocation of said funds; and

WHEREAS, pursuant to said MOU, Otero County and each municipality shall delegate a representative to serve on said committee to represent its body on the committee and to sign agreements on behalf of its respective political body and to bind said body; and

WHEREAS, Otero County desires to name Amy White-Tanabe as its representative;

NOW, THEREFORE, **BE IT RESOLVED** by the Board of Commissioners of the County of Otero, Colorado, that:

1. County Administrator Amy White-Tanabe shall serve as the representative for Otero County on the committee formed to determine the allocation of the funds received from the United States Treasury's Coronavirus Relief Fund pursuant to the CARES Act.

- 2. County Administrator Amy White-Tanabe shall have the authority to sign agreements on behalf of Otero County as concerns the allocation of said funds and to bind Otero County pursuant to said agreements.

This letter is to inform you that,

After discussion among The Otero County Board of Commissioners, Otero County Sheriff, Otero County Emergency manager and Chiefs of the following Fire Districts, Fowler, Manzanola, Rocky Ford, La Junta, and Cheraw, Otero County will be enacting Stage 1 fire restrictions. With the recent lack of significant moisture along with the 120-day fire outlook, conditions for large unpredictable wildland fires are high.

STAGE 1 RESTRICTIONS

OPEN BURNING, EXCEPT FIRE AND CAMPFIRES WITHIN CONSTRUCTED FIRE GRATES INSIDE DEVELOPED CAMP AND PICNIC GROUNDS, CHARCOAL GRILLS AND WOOD BURNING STOVES AT PRIVATE RESIDENCES. THESE AREAS MUST BE CLEARED OF ALL FLAMMABLE MATERIALS. (EXEMPTIONS ALLOWED FOR AGRICULTURAL BURNING ON A CASE BU CASE BASIS MAY BE GRANTED BY THE APPROPRIATE FIRE DISTRICT.)

THE SALE OR USE OF FIREWORKS WITHOUT A PERMIT.

OUTDOOR SMOKING EXCEPT INSIDE A VEHICLE OR STOPPED IN AN AREA AT LEAST THREE FEET IN DIAMETER THAT IS BARREN OF ALL FLAMMABLE MATERIALS.
