Chr. Goodwin called the meeting to order and requested approval of the minutes from June 15th, 2020. Co. Hostetler motioned to approve minutes. Chr. Goodwin seconded. Motion carried.

Admin. White-Tanabe presented the Sales Tax Report. The County is doing well at a cumulative percent of change of 9.15, which is better than expected considering the unknown with the COVID crisis.

Admin. White-Tanabe presented 2 separate letters of appointment for the Otero County Historic Preservation Board. The letters are reappointments for Jill Manley and Kevin Lindahl. The terms are for 3 years beginning on January 2020 and going through January of 2023. A point of interest: Kevin Lindahl is the outgoing president and Jill Manley is the incoming president. Co. Hostetler motioned to approve signature on both letters. Chr. Goodwin seconded. Motion carried.

Admin. White-Tanabe presented an Agreement between the Board of County Commissioners of Otero County and the Valley View Electric LLC. The agreement is for work to be done on the generator for the Otero County Sheriff's Office. Valley View Electric LLC was the bid winner. The hope is to have the work completed by the end of the year. Co. Hostetler motioned to approve signature on the contract. Chr. Goodwin seconded. Motion carried.

Danelle Berg reported on the enterprise grant project, they are working on getting more donors to help with the small business owners who are affected by COVID. There is a new donor interested but they would like current monies to be expended prior to adding to it. She has had several potential new business referrals from SBDC, in Las Animas and Otero Counties. She is working with Carol Carter an author who would like to help donate books to Otero County and Lamar Community College they will need to be picked up by August 15th. The books will be useful resources for anyone going into a 2 year or 4 year college. The El Pomar Grant will be making a decision in July about the canopy over the grandstand for the Kids Rodeo grounds.

Clerk Scott wanted to remind everyone that June 30^{th} , is Election Day. The Clerk's office will be closed for all business but Elections. She also wanted to let everyone know that the office will be open on the 27^{th} , June for Elections from 8-12.

Admin. White-Tanabe reported that she is in discussions about automation of functions in the administration office to make it more efficient. Would like to do more telecommunication as some departments have benefited from remote workers. She has been in several meetings about the CARES act.

Co. Hostetler reported that he attended a Zoom call with CDPHE about the fair guidelines and talked to the emergency manager about the fires and the efforts to keep them out of Otero.

Chr. Goodwin met with the Sheriff's department about a new position opening in the jail to put it in the new salary survey so that the job is defined correctly. He also met with the fair board and there are concerns about what can be put on because of social distancing. There will be limitations on the venue of the fair to make sure that social distancing can be done. SEBREA met through Zoom last week and a lot of the discussions were about COVID and the CARES act. There was also discussion about SpaceNet a satellite base broadband, the county may be able to be a part of the pilot program. Chr. Goodwin also talked about the opioid lawsuit, there is a settlement but the county will be declining that as they would have to put in with everyone else as a class action suit.
