Chr. Oquist asked everyone to stand for Prayer and the Pledge of Allegiance.

Chr. Oquist called the regular meeting to order.

Rebecca Goodwin and Tammy Ridennoure, with the Otero County Historic Preservation Board, presented an educational workbook and teacher's guide for 3rd graders throughout the County on historical events and people that made a difference or contributed to our County. The books were funded by the CO2 Grant Project. The budget was \$14,070.00 and came in \$1,199.00 under budget due to over a thousand hours and over \$54,000.00 dollars' worth of volunteer or in-kind donations. The book is called Windows and Mirrors because if the 3rd graders can see themselves in it, they will have ownership in it and they will take care of it. At the end of the 2025-26 school year, a letter will be sent out asking what the schools thought of the books, what worked and what did not. Discussion was held. Mrs. Goodwin invited the Commissioners to the ceremony for the Manzanola United Methodist Church by the History of Colorado group on June 8, 2025, at 1:00pm for recognition of being added to the National Register.

Chr. Oquist called for approval of the consent agenda. The agenda includes approval of the minutes from May 12th, 2025, and bills and payroll for May 1st through May 15th, 2025. Co. Knabenshue motioned to approve the consent agenda. Co. Baldwin seconded. Motion carried.

Admin. White-Tanabe presented Resolution 2025-13 A Resolution Amending the Personnel Management Handbook. This will add clarity, consistency, and readability without making material changes to policies. Co. Baldwin motioned to approve the resolution. Co. Knabenshue seconded. Motion carried.

Admin. White-Tanabe presented the sales tax report for March 2025. There was a 7% cumulative change from last year of \$247,126.00.

Co. Baldwin reported that he attended the Southeast Colorado Water Roundtable, and it sounds as though Otero County, and the Arkansas Valley could have issues with water this year due to only a 57% snowpack in the mountains. Co. Baldwin and Co. Knabenshue attended the Colorado Water Conservation Board (CWCB) meeting. The highlight of that meeting was the 16 counties wanting to buy out the Arkansas waterway.

Co. Knabenshue reported that he also attended the Southeast Water Conservancy District meeting, as well as OCLI. He also visited the DA building to see the progress of the renovation going on there.

Chr. Oquist reported that he attended several of the same meetings as Commissioner's Baldwin and Knabenshue. He also attended meetings with Sage Nutrition Services, Southeast Colorado Business Retention Expansion and Attraction (SEBREA), and Region Six Alcohol & Drug Abuse Corporation (RESADA). Chr. Oquist announced that they would be attending a CCI Conference next week.

With no further business, the Board adjourned the meeting.
