Chr. Oquist asked everyone to stand for Prayer and the Pledge of Allegiance.

Chr. Oquist called the regular meeting to order.

Chr. Oquist called for approval of the consent agenda. The agenda includes approval of the minutes from June 9<sup>th</sup>, 2025, and bills and payroll for June 1<sup>st</sup> through June 15th, 2025. The board approved the re-appointment of Dave Hill and Matt McIntyre to the Otero County Planning Commission. The board approved the Department of Human Services Financial Report for April 2025. Co. Baldwin motioned to approve the consent agenda. Co. Knabenshue seconded. Motion carried.

Danny Chavez presented a Memorandum of Agreement, Fiscal Agent and Reimbursement Agreement for approval. This gives Baca County permission to act as fiscal agent for Otero County as part of the Southeast Colorado Region for the federal grant for the Colorado All Hazards Board. Co. Knabenshue motioned to approve. Co. Baldwin seconded. Motion Carried.

Admin. White-Tanabe presented a letter to accept Prop 123 Incentive Funds and a letter related to the abatement expense request. Co. Baldwin motioned to approve. Co. Knabenshue seconded. Motion Carried.

Admin. White-Tanabe presented the contract award for SM Construction. SM Construction bid \$589,350.00 for the Fowler County Road and Bridge Shop redevelopment after the fire. Co. Knabenshue motioned to approve. Co. Baldwin seconded. Motion carried.

Admin White-Tanabe reported the sales tax earned in April and received in June was up 3% based on comparisons from the last two years.

Co. Baldwin attended a Round Table Meeting.

Co. Knabenshue worked on leadership training and planning for the County employees. Water meetings continued. One was with Dr. Bartolo last week. Attended several meetings for a Southeast Grant for thriving communities with other Southeast Counties. Also, spoke with Congressman Jeff Hurd.

Chair Oquist attended Region Six Drug & Alcohol Abuse (RESADA), Southeast Colorado Business Retention, Expansion, and Attraction (SEBREA), SAGE Service meetings, and a meeting with Congressman Jeff Hurd. He attended a press conference with Southeast Colorado Opioid Response (SECOR) Region 19 group awarded a grant for Fort Lyon and Lamar to rehabilitate buildings to house people.

Admin White-Tanabe announced the County offices will be closed July 4, 2025, for the 4th of July holiday.

With no further business, the Board adjourned the meeting.
