Chr. Oquist asked everyone to stand for Prayer and the Pledge of Allegiance.

Chr. Oquist called the regular meeting to order.

Chr. Oquist called for approval of the consent agenda. The agenda includes approval of the minutes from June 10th, 2024, bills, and payroll for June 1-15, 2024, approval of the Otero County Planning Commission Board Reappointments, and approval of Financial Statements-General Human Services, ending May 31, 2024. Co. Knabenshue motioned to approve the consent agenda. Chr. Oquist seconded. Motion carried.

Southeast Colorado Regional Housing Authority Representative Michael Yerman presented information on the Intergovernmental Agreement (IGA) between the 6 counties in the region: Baca, Bent, Crowley, Kiowa, Otero, and Prowers. This IGA is to establish a multijurisdictional housing authority. Mr. Yerman wanted to make clear that the Authority would not have any taxing powers and would not be able to initiate any ballot initiatives that would advocate for taxes or affordable housing. Co. Knabenshue asked about the managing entity. Southeast Colorado Enterprise Development, Inc. (SECED) has agreed to be the managing entity. Co. Knabenshue motioned to approve the IGA. Chr. Oquist seconded. Motion carried.

Admin. White-Tanabe presented Resolution 2024-10. This Resolution approves an agreement between Otero County, Colorado, and Crowley County, Colorado, establishing The South Swink Water Authority to be in Otero County. This is to help with the development of water resources. Co. Knabenshue motioned to approve Resolution 2024-10. Chr. Oquist seconded. Motion carried.

Admin. White-Tanabe presented the sales tax report for April of 2024. We are at a 4% cumulative percentage of change. Overall, the county is doing well. Admin. White-Tanabe also reported that she has been working on office and county policies. Supporting the Emergency Operation Center, with all the tragedies in our area. She has started working on the budget for 2025, already. Co. Knabenshue wanted to thank her and our first responders for all they do and have done for the county and its people.

Clerk Scott mentioned that the voter turnout for the Primary so far has been low and is low across the State.

Co. Knabenshue presented that he has meetings with the CSU Extension and heard about all the summer events they have going on. He attended the Southeast Colorado Water Conservancy District meeting. They talked about water run-off and storage. There was a town meeting with Rep. Winter and Sen. Pelton, it was a good meeting.

Chr. Oquist attended several of the same meetings as Co. Knabenshue. He did mention that he sat in on the one with Rep. Winter and Sen. Pelton after the SEBREA meeting. He enjoyed listening to the CSU Extension office meeting because they are very busy with the 4-H kids, as they help with them during the fair season.

Admin. White-Tanabe made the announcements that the County offices would be closed for the 4th of July and that the meeting for July 8th has been canceled.

With no further business, the Board adjourned the meeting.

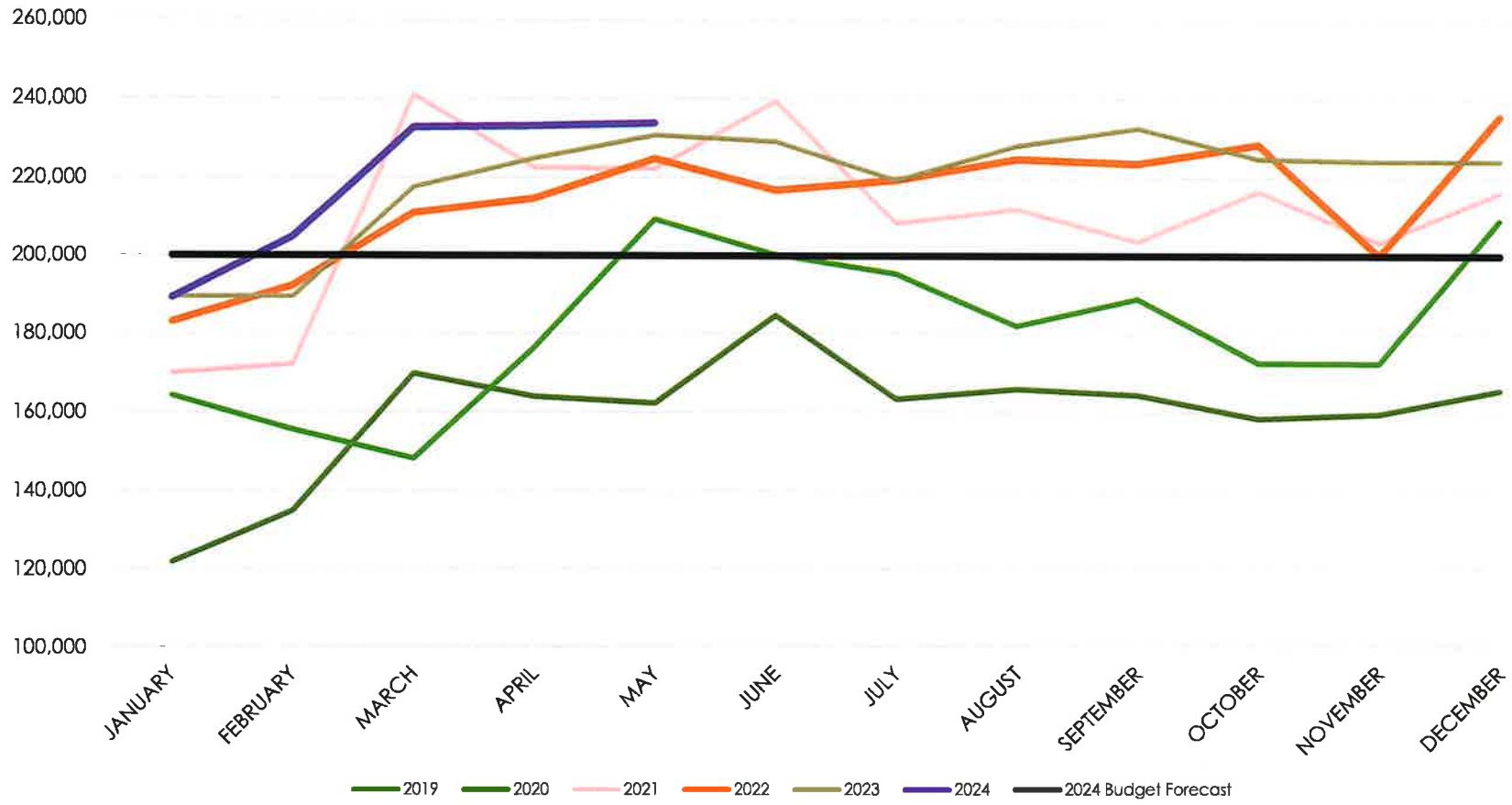
