Chr. Baldwin called the meeting to order and asked for public comment. Jody Bracy, who is a Veteran Advocate, is in support of more help for veterans instead of closing the VA Clinics. She is here to support the Resolution to keep the VA Clinic open in Otero County. Ms. Bracy uses Community Care for veterans and there is at least a month wait for call backs. Veterans in the counties where they are considering closing the clinics would not have access to healthcare, closing the clinics will put undue hardship on veterans to get help. Co. Oquist stated that he himself was not a veteran, but he had family members who were, and said he and the commissioners wanted to do what was best for our veterans.

Chr. Baldwin motioned for approval of the Consent Agenda. The agenda contains: approval of the minutes from June 27th, 2022, and approval of bills and payroll. Co. Oquist motioned to approve the consent agenda. Co. Hostetler seconded. Motion carried.

Admin. White-Tanabe presented an ambulance permit for approval for American Medical Response dba MedTrans. This will be a replacement and upgrade to one with a life-support system. Co. Hostetler motioned to approve. Co. Oquist seconded. Motion carried.

Admin. White-Tanabe presented Resolution #2022-07, a Resolution Opposing the Closure of the La Junta VA Clinic. The closing of the clinic would be detrimental to the health and well being of the veterans who live and need VA health care in the area. The County Commissioners would encourage all eligible vets with DD214's to enroll in VA health care. Co. Oquist motioned to approve the Resolution. Co. Hostetler seconded. Motion carried.

Rick Ward Otero/Bent County Veteran Service Officer thanked the Commissioners for the Resolution to support not closing the VA Clinics in the area. He also gave information on what it took to qualify for VA health care; the vet must have been honorably discharged. National Guard vets, unless they were called up to active duty or injured during active duty, do not qualify as a rule. Chr. Baldwin, along with Commissioners Hostetler and Oquist, congratulated Mr. Ward on his new position as the County Veteran Service Officer. Rick is a veteran of the U.S. Coast Guard and a graduate of the Coast Guard Academy.

Lex Nichols, Otero County Land Use Administrator, presented that he agreed with the letter from the Commissioners to appoint Matthew McIntyre to the Otero County Planning Commission for a term of three years beginning in July of 2022, because Vince Tatum has stepped down. Lex also reported as the Public Works director that chip-n-seal with be starting on county roads on July 19th. Co. Oquist motioned to approve the letter of appointment. Co. Hostetler seconded. Motion carried.

Admin. White-Tanabe reported that she is beginning the budget process for 2023.

Co. Hostetler shared that he attended several meetings during the week.

Co. Oquist reported that he met with Senator Michael Bennett's representatives and local farmers. They discussed the farmers' concerns with the fees to get workers here and expressed concern over water, as that could become an issue in the next year.

AGREEMENT FOR RELEASE AND WAIVER OF CLAIMS

THIS AGREEMENT for Release and Waiver of Claims ("Agreement") is made and entered into this 25 day of July 2022, by OTERO COUNTY, COLORADO ("Donee") for the benefit of and to be enforceable by the City of Pueblo, a Municipal Corporation ("Donor").

WITNESSETH:

WHEREAS, Donor owns one row hangar, subdivided into ten T-hangars and two storage units, located at 32101 Walt Bassett Avenue, Pueblo, Colorado on the Pueblo Memorial Airport (herein the "Property"), which are surplus to its needs and is willing to transfer the Property to Donee; and

WHEREAS, the Donee has agreed to accept the Property in its current condition without warranty and to release Donor from any and all claims and demands with respect to the condition or future use of the Property; and

WHEREAS, the Donee desires to enter into this Agreement for the benefit of Donor, setting forth the terms and conditions of its acceptance of the Property.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the parties hereto agree as follows:

- 1. <u>Transfer.</u> Donor donates and transfers all its right, title, and interest in and to the Property to the Donee and Donee accepts such transfer.
- 2. <u>Disclaimer of Warranty</u>. DONEE ACCEPTS THE PROPERTY "AS IS, WITH ALL ITS FAULTS." DONOR MAKES NO WARRANTY, EXPRESS OR IMPLIED, AS TO ANY MATTER WHATSOEVER, INCLUDING, WITHOUT LIMITATION, THE HABITABILITY, DESIGN, OPERATION OR CONDITION OF THE PROPERTY, ITS MERCHANTABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE, THE ABSENCE OF LATENT OR OTHER DEFECTS (WHETHER OR NOT DISCOVERABLE), AND DONOR HEREBY DISCLAIMS THE SAME.
- Release and Discharge. Donee agrees to completely release and forever discharge Donor and its agents, employees, and officers of and from any and all claims, liabilities, or causes of action, whether known or unknown, disclosed or undisclosed, material, or immaterial, liquidated or unliquidated, which Donee or its officers, agents, and employees may have or may hereafter have against the Donor for or by reason of any matter, cause, or thing relating to the transfer, use, or condition of the Property.
- 4. Donee shall indemnify, defend, and hold harmless the Donor and its officers, agents, and employees from any and all claims, actions, assessments, demands, liabilities, causes of action, whatsoever which may arise after the date of this Agreement out of the transfer,

use, operation, or condition of the Property.

- 5.
