The Board of County Commissioners now meets pursuant to adjournment.

Guests in attendance were: In person: Jolly Rose, Danelle Berg, Mark McCuistion and Stephen Anderson. On phone: Marty Lee and Anne Boswell.

Chr. Goodwin called the meeting to order and requested approval of the minutes from July 27<sup>th</sup>, 2020. Co. Hostetler motioned to approve the minutes. Co. Baldwin seconded. Motion carried.

Mark McCuistion addressed the Board with questions about the shutdowns. He was wanting to know who determines the numbers attributed to COVID-19. He also wants to know how the accountability is processed. Chr. Goodwin stated that the Doctor in charge of patient is in charge of how the death certificate is filled out. Mr. McCuistion feels that one size does not fit all and he doesn't feel that the requirements are indicative of area.

Stephen Anderson also wanted to address the Board with concerns of the restrictions put in place because of COVID-19. He also has questions about why one size fits all, when he doesn't feel it should. He feels that the elected officials take accountability on what goes on in our county.

Chr. Goodwin presented the bills from July 16 to July 31, 2020. Co. Baldwin motioned to approve the bills. Co. Hostetler seconded. Motion carried.

Danelle Berg mentioned the detention center, she has received the final draft, but she has not finished it yet. Still working with the Trinidad to finish a business that will be opening. She mentioned that there are several people looking for space for potential business. The Small Business development center is working hand in hand to get everyone set up.

Admin. White-Tanabe reported that we received the contract from DOLA for the CARE Act monies. She will be meeting with the Committee to decide on how to move forward. Admin. White-Tanabe and the Commissioners met with Gallagher who is our health insurance broker to determine where we stand. She is working on the budget, and met with the department heads as well as the commissioners about new policies that may be in the works.

Co. Hostetler had a good week. He said that the Health Department has been doing more COVID-19 testing. Attended a zoom meeting with Ken Buck. He also attended a zoom meeting with RMMI about the timesheets.

Admin. White-Tanabe announced that the 16th Judicial District will resume jury trials in August.

With no further business, the board adjourned the meeting.
