Chr. Baldwin motioned for approval of the Consent Agenda. The agenda contains: approval of the minutes from July11th, 2022, with a correction to the guest list, Adrian Hart was listed twice. Approval of bills and payroll. Co. Hostetler motioned to approve the consent agenda. Co. Oquist seconded. Motion carried.

Admin. White-Tanabe presented an Agreement for Release and Waiver of Claims between Otero County and the City of Pueblo concerning the donation of 10 hangers to the City of Fowler airport. This will provide general aviation patrons a place to park their planes and it will also include general storage. Co. Oquist motioned to approve the ratification of the agreement. Co. Hostetler seconded. Motion carried.

Sharon Jones of the Treasurer's Office gave the Public Trustee 2nd Quarter Report. There were 230 release deed of trusts and 11 new foreclosures. Total income: \$8,588.92, total expenditures: \$5,873.99 for a total of \$2,714.93 going to the Treasurer. Ms. Jones also gave the Semi-annual report for the Treasurer's office. Grand total of semi-annual report is: \$24,886,108.32. Co. Hostetler motioned to approve report. Co. Oquist seconded. Motion carried.

Jesse Howells gave a report on the official closing of the landfill. The landfill will be closing on February 23, 2023. Everything else is going well. They received a new compactor last week and it is doing better. The building is coming along, all the electrical and plumbing is in, and the inspection should be done soon. Once that is done then the drywall will start.

Clerk Scott reported that the election went well. We may still have to do a recount; two candidates may ask and pay for a recount of their races. Ms. Scott announced that herself and Shannon would be attending a liquor license class in Pueblo on the 5th of August and the week of the 8th through the 11th, they will be in Salida for conference.

Admin. White-Tanabe presented that she is working on funding and continued funding for the detention center. She is also working on the 2023 Budget project with meetings coming up soon.

Co. Oquist reported that he and Co. Hostetler spent most of the week at the National Commissioners Convention. They had a good time, and it was a great eye-opener. This was the first time it was held in Denver. They talked about the judicial system and the water issues.

Co. Hostetler was glad to be able to go, he truly enjoyed the experience. He attended meetings about the VA and care for veterans. Co. Oquist mentioned that the Armed Services are starting to do more to help veterans transition to civilian life.

With no further business the Board adjourned the meeting.

FOURTH AMENDMENT/ADDENDUM TO CONSTRUCTION CONTRACT

THIS FOURTH AMENDMENT/ADDENDUM TO CONSTRUCTION CONTRACT is made and entered into this 8th day of August, 2022, by and between **BOARD OF COUNTY COMMISSIONERS OF OTERO COUNTY, COLORADO**, hereinafter referred to as "County", and **SM CONSTRUCTION, INC.**, hereinafter referred to as "Contractor".

WITNESSETH:

- WHEREAS, on October 25, 2021, County and Contractor entered into a Construction Contract wherein Contractor agreed to perform work to be done in the Otero County Courthouse located at 13 West Third Street, La Junta, Colorado, described as "design/build of a single-entry of the courthouse and a remodel of judicial space"; and
- **WHEREAS**, on January 10, 2022, County and Contractor entered an Amendment/Addendum to Construction Contract; and
- WHEREAS, on April 11, 2022, County and Contractor entered into an Amendment/Addendum to Construction Contract; and
- WHEREAS, on May 9, 2022, County and Contractor entered into an Amendment/Addendum to Construction Contract; and
- WHEREAS, the County has now determined that slurry sealing, and restriping of the north and south parking lots are necessary; and
- WHEREAS, pursuant to paragraph 20 of the Construction Contract, the County is requesting a "Change to Work" as more fully set forth below and Contractor agrees to the same; and
- WHEREAS, compensation and time of completion will be affected by the "Change to Work", and said changes must be reduced to writing pursuant to the terms of the Construction Contract.
- NOW, THEREFORE, in consideration of the mutual covenants herein contained, and other good and valuable consideration, the receipt of which is acknowledged, the parties agree as follows:
- 1. The Construction Contract dated October 25, 2021, between County and Contractor is hereby amended as follows:
 - (a) Article 3 of the Construction Contract is amended to include "slurry sealing, and restriping of the north and south parking lots" to the Contract Documents (Section 3.1) describing the work to be

done for the repair and improvement of the north and south parking lots, a copy of which is attached.

(b) Article 6 of the Construction Contract is amended to read as follows:

ARTICLE 6. <u>CONSIDERATION</u>: County shall pay Contractor up to the sum of \$892,891.00 for the performance of the Work described in the Contract Documents as the "design/build a single-entry to the Courthouse and to remodel judicial space" project, subject to additions and deductions by Change Order as provided for hereinafter.

(b) The additional \$13,915.00 for the change order for the parking lot brings the project total to \$892,891.00.

County shall pay Contractor for its services as follows:

- (a) The Contractor may submit a request for payment on a monthly basis for the work Contractor has completed. Payment will be made within thirty (30) days of receipt of invoice, subject to Article 11, below;
- (b) The County will withhold 5% of each request for payment and will release the withheld 5% upon the County's approval of the successful completion of the project as determined by the County at its sole discretion. (C.R.S. 24-91-103).
- (c) After completion of the project, provided the Contract be then fully performed, subject to the provisions of Article 12 herein, the County shall publish a Notice of Final Settlement twice at least 10 days prior to the date of Final Settlement. The County shall withhold from final payment any amounts as required pursuant to C.R.S. 38-26-107.

The parties agree that if there is a drastic escalation in the cost of materials, Contractor shall notify County of the need to meet to discuss the increase in costs. Contractor agrees to provide a spreadsheet showing the cost of materials at the time of bidding and the cost of materials at the time of requesting the meeting.

2. That all other Terms and Conditions which are not inconsistent with this Amendment/Addendum shall remain in full force and effect.


