The Board of County Commissioners now meets pursuant to adjournment.

Chr. Oquist asked everyone to stand for prayer and to recite the Pledge of Allegiance.

Chr. Oquist called the regular meeting to order.

Chr. Oquist called for approval of the consent agenda. The agenda includes approval of the minutes from August 14th, 2023, and bills and payroll for August 1st, 2023 – August 15th, 2023. Co. Baldwin motioned to approve the consent agenda. Co. Knabenshue seconded. Motion carried.

Admin. White-Tanabe talked about the asbestos abatement contractor selection. We published a request for proposal for the current jail and Sherrif building to be abated before demolition. We received 5 bids for that project. We mathematically scored each with 60% of the score being the target date of completion. The second was scored on location. How many miles they are from Otero County, or here in La Junta at the courthouse. And lastly 30% of their score has to do with the cost proposal. Out of the 5 proposals, the cost ranged from \$52,851.00 up to \$360,000.00. In review of the 5 bids, Admin. White-Tanabe suggested the board consider Earth Services from Commerce City with a completion date of September 15, 2023. Their cost proposal was also the lowest cost at \$52,851.00. The closest bidder was in Pueblo West Colorado. Co. Knabenshue motioned to approve Earth Services from Commerce City for the asbestos abatement removal contract. Co. Baldwin seconded. Motion carried.

Admin. White-Tanabe has reviewed a grant application for SECRETAC, Southeastern Colorado Regional Emergency Trauma Advisory Council. The application is from Otero County EMS. They have applied for a \$15,000.00 grant. If funded, they would provide money to La Junta Fire, Rocky Ford Fire, Fowler Fire, and some education for East Otero School District. The funds would also be used for ambulance inspections and medical direction. Admin. White-Tanabe suggests the board approve the grant application for SECRETAC. Co. Baldwin motioned to approve the grant application for SECRETAC. Co. Knabenshue seconded. Motion carried.

Admin. White-Tanabe gave the Sales Tax Report for June 2023 that was received in August 2023. The total collected was \$229,251,00. This was an increase of \$12,000.00 and 5.7% as compared to June of 2022. Comparing 2022 to 2023, we are ahead by 3.14%. Admin. White-Tanabe believes we will most likely meet our budget.

Admin. White-Tanabe spoke to the board about applying for a grant of \$5,800.00 with SECOG, Southeast Council of Government. This money has a 50/50 match. The money would be used to update the flooring and window coverings in the Bauserman room.

Co. Knabenshue spoke about the parades and meals involved with the County Fair. He represented Otero County at the SECOG meeting with discussion of grants and projects going on throughout the region. He also attended the SCED meeting with discussion of current housing projects being completed, along with future housing projects that are coming down from Prop 123. He reported on Hwy 50 and 71 constructions. There will be lights installed, however, due to supply shortages, we are looking between 3 to 6 months for completion. He also spoke about the Clean Valley Recycling meeting.

Chr. Oquist spoke about the Clean Valley Recycling meeting. The landfill was closed in Manzanola and the only landfill available is south of Swink. It doesn't take long to fill, to dig a new hole is very expensive.

Admin, White-Tanabe announced all County offices will be closed on September 4th for Labor Day.
