Chr. Baldwin motioned for approval of the Consent Agenda. The agenda contains: approval of the minutes from August 8<sup>th</sup>, 2022, and approval of bills and payroll. Co. Hostetler motioned to approve the consent agenda. Co. Oquist seconded. Motion carried.

Admin. White-Tanabe presented Resolution 2022-009, Authorizing Execution of Certificates of Participation for the Funding of a new Detention Center and Sheriff's Administrative Offices. The aggregate amount shall not exceed \$15,500,000. The interest rate is set at 4.75 %. Since we are paying other counties to house inmates for us, that line item will then be used to pay off the Detention Center. Alan Matlosz, talked about the funds and how they will be used to build and set up the Detention Center. Co. Oquist motioned to approve the Resolution 2022-009. Co. Hostetler seconded. Motion carried.

Danny Chavez, Emergency Manager presented to the Board that along with Sheriff Mobley and the Fire Chief he would recommend that the fire restrictions be lifted. Co. Hostetler motioned to approve lifting the fire restrictions. Co. Oquist seconded. Motion carried.

Admin. White-Tanabe presented the sales tax report. We are at 20.27% cumulative percent of change. The monthly change is -9.46%. We went down but overall, still doing well.

Sheriff Mobley thanked the Commissioners for approving the detention center resolution.

Danny Chavez mentioned that his department is busy with trainings.

Clerk Scott talked about the conference that was attended, by her and Shannon. The biggest change being the park pass and what that might entail.

Admin. White-Tanabe mentioned that she was working on the certificate for the jail and budget,

Co. Hostetler mentioned that he attended the Fair, and the RESADA meeting.

Co. Oquist also attended his regular meetings. He also attended the Fair and the parades, a very busy week.

With no further business the Board adjourned the meeting.

WHEREAS, The County Treasurer for Otero County, Colorado, Howard Dennis Smith has vacated his duties as treasurer and public trustee; and

**WHEREAS**, in accordance with C.R.S. 30-10-705, the deputy treasurer, Sharon K. Jones, has been the acting treasurer since May 3, 2022; and

WHEREAS, in accordance with the Colorado State Constitution, Section 9 of Article 14 the Otero County Board of County Commissioners has the duty to appoint an acting Treasurer to finish the term of Treasurer Smith; and

WHEREAS, in accordance with C.R.S. 38-37-102(2)(a) the County Treasurer shall act as the Public Trustee.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the County of Otero, Colorado that:

- 1. The acting treasurer, Sharon K. Jones, is hereby appointed as Otero County Treasurer until the regularly scheduled election in November 2022.
  - 2. This appointment is effective the 12<sup>th</sup> day of September 2022
