Chr. Goodwin called the meeting to order and requested approval of the minutes from August 31st, 2020. Co. Hostetler motioned to approve the minutes, with correction to paragraph 10, Joey Harrison should be Joseph Gacnik. Co. Baldwin seconded. Motion carried.

Admin. White-Tanabe presented the CDBG Participation Plan for the Community Development Block Grant due to COVID-19. Otero County along with DOLA is applying for a grant, they want to be able to develop a plan for a capital improvement project, to help with the detainees at the jail as the County was not able to provide a safe place for the detainees. We were outsourcing detainees which is detrimental to the wellbeing of the County. This is an \$800 Thousand dollar project with no match required. Jolly Rose and Adrian Hart spoke for the project, they were glad that we were looking into different ways to help finance.

Admin. White-Tanabe presented a letter of support for the Bent's Fort Chapter of the Santa Fe Trail Association's application for a State Historical Fund grant.
