The Board of County Commissioners now meets pursuant to adjournment.

Chr. Oquist asked everyone to stand for prayer and to recite the Pledge of Allegiance.

Chr. Oquist called the regular meeting to order.

Lisa Trigilio, Program Director for Fort Lyon, came to inform the Commissioners that the Ft. Lyon Residential Supportive Community has been at Ft. Lyon for 10 years. They hold a contract to maintain the facility, run the recovery program and they are funded by The State of Colorado. Ms. Trigilio would like to invite the community to their 10-year Celebration on October 11th, 2023. It will be an opportunity to see what Ft. Lyon does and hear some of the stories of the people Ft. Lyon has helped. Ft. Lyon has helped 2700 Colorado residents in the program, and it has changed their lives. Ft. Lyon would like to be seen as a resource for help. Ft. Lyon only serves Colorado residents 18 years old or older and are at risk of becoming homeless. They must be accepted into the program and there is an application. The program is for 3 years, and it can be repeated as need be. They can attend voluntary recovery programs. The Colorado Coalition for the Homeless can and does at times hire residents to help maintain the grounds. They can house 245 people but try to keep it to 225, that way they can add more people as needed. They have a 60-person staff not including the residents. Veterans have priority and they do have a veteran group there. Ft. Lyon gets about 5.6 million dollars through grants to help maintain the grounds and run the program. They have a transition team that works with the residents within 6 months. Discussion was held.

Chr. Oquist called for approval of the consent agenda. The agenda includes approval of the minutes from August 28th, 2023, and bills and payroll for August 16th, 2023 - August 31st, 2023. Co. Knabenshue motioned to approve the consent agenda. Co. Baldwin seconded. Motion carried.

Admin. White-Tanabe presented them Earth Services contract for ratification on the removal of asbestos from the county jail. Chr. Oquist signed the contract on August 31, 2023, to get the process started. Co. Baldwin motioned to approve the ratification of the Earth Services contract. Co. Knabenshue seconded. Motion carried.

Clerk Scott presented the special liquor license for approval for the Arkansas Valley CASA's Boots n' Bling benefit dinner. The dinner dance is on the 30th of September 2023. Co. Knabenshue motioned to approve the liquor license for the CASA dinner dance. Co. Baldwin seconded. Motion carried.

Admin. White-Tanabe mentioned that she is working on budgets. The budget packets are due on Friday, and they are setting up budget meetings to be held next week.

Co. Knabenshue and Chr. Oquist attended several of the same meetings. The meetings were: The Southern District meeting in Monte Vista, CO., the jail construction meeting where they went through the blueprints and looked at everything. Chr. Oquist said that the Southern District meeting was interesting because everyone seemed to be having issues with their jails. Co. Knabenshue attended the CASA meeting where they swore in 3 new volunteers.

With no further business the Board adjourned the meeting.

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF OTERO COUNTY, COLORADO, OPTING INTO PROPOSITION 123

WHEREAS, the voters of Colorado approved Proposition 123 in 2022 creating the State Affordable Housing Fund to make certain funds available to local governments as defined by CRS-29-32-104; and

WHEREAS, Otero County, Colorado is a Statutory County duly and regularly organized and validly existing as a body corporate and politic under and by virtue of the Constitution and laws of the State of Colorado and is eligible for Proposition 123 funding and programing; and

WHEREAS, the Board of County Commissioners Authorizes the County staff to opt-in and set a baseline for the development of affordable housing as defined Proposition 123; and

WHEREAS, with technical funding assistance from the Colorado Department of Local Affairs the County will begin the formal process to review its Zoning code for the possible adoption the "Qualified Strategy" for "fast track review" for affordable housing applications to comply with Proposition 123.

Otero County hereby elects to opt-in to Proposition 123 setting its baseline of 433 units with the goal to increase the County's affordable housing units by thirteen (13) units a year or annualized goal of thirty nine (39) units over 3 years.

WHEREAS, C.R.S. 29-1-203 authorizes and encourages intergovernmental agreements and contracts for the purpose of governmental entities to cooperate and contract to provide a function, service, or a facility; and

WHEREAS, Otero County and the Town of Fowler entered into an intergovernmental agreement concerning the building located at 317 Main Street, Fowler, CO 81039; and

WHEREAS, the Town of Fowler renovated its building located at 317 Main Street, Fowler, CO 81039 and borrowed the sum of seven thousand five hundred dollars (\$7,500.00) from Otero County to complete the renovation project and executed a Promissory Note at that time on October 18, 2022; and

WHEREAS, the Town of Fowler sold the building located at 317 Main Street, Fowler, CO 81039; and

WHEREAS, the Town of Fowler paid Otero County the required seven thousand five hundred dollars (\$7,500.00) with check #131462 on February 2, 2023; and

WHEREAS, Otero County wishes to release the Town of Fowler from the Promissory Note; and

WHEREAS, Otero County desires to file this Release of Promissory Note with the Otero County Assessor's Office and with a copy to ABC Title.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of the County of Otero, Colorado as follows:

- 1. The County of Otero hereby fully and without reservation or other consideration releases the Town of Fowler from the October 18, 2002 Promissory Note.
- 2. Such Release of Promissory Note should be duly reflected at Reception No. 5890427, File #062222 that the Town of Fowler paid seven thousand five hundred dollars (\$7,500.00) with check #131462 on February 2, 2023 to the County of Otero.


