Chr. Baldwin called the meeting to order and requested approval of the minutes from August 23rd, 2021. Co. Oquist motioned to approve the minutes with the correction of Anne Boswell as a guest via zoom. Chr. Hostetler seconded. Motion carried.

Timothy Ahopelto, with Hinkle & Company, reported on the 2020 Audit for Otero County. They will go over the County operations and internal controls, they also look at procedures and do testing to make sure the controls work. There was a E911 adjustment in capital. There were no management problems. Mr. Ahopelto thanked Ms. Tina Macarenas for all her help and the County for working with them.

Chr. Baldwin called Julie Worley to the podium concerning mask mandates. There was a resolution presented to the board and there were several people who testified on it. Julie Worley read the resolution to the board; it is attached to the minutes. The following is a list of the people who spoke out concerning mask mandates:

Sunny Eddy, small business owner—communities depend on small businesses, he expressed concern over the mask mandates, as an American citizen we have freedoms. He is requesting that the Health Director be eliminated and that the Board of County Commissioners take over.

Carolyn Ehrlich concerned citizen—had COVID-19 and took steps to help take care of it herself-she attended a protest and was very disappointed in the attitude of the Health Director.

Kerry Froese wrote a letter that Julie Worley read aloud: a copy to be attached. Kerry wrote a letter of opposition to the mask and vaccine mandates. She feels that the mandates overstep the law.

Jessica Goodwin, spoke about her concerns for the children being affected by the mask mandates. The flu season lasts 8 months and so far, the COVID mask mandates have gone on for over 20 months. She feels that our freedoms are being taken away, and she will stand up to protect the freedoms and would like to see our board do the same.

Steven Hicks, Pastor—would like to see the board uphold the rights of citizens to choose whether they get the vaccine or not. A vaccine mandate goes against the God-given rights provided by the Constitution of the United States. The government is supposed to protect our rights, not try to run our lives.

Isaac Morkus, vaccinated individual—He is a college student, he has a friend that was pressured into taking the shot and feels that it should be a choice of the individual and would like to see the mandate rescinded, and just let us live our lives the best way we can.

Damon Nichols, business owner—there has been a gross overreach of public officials. Health care is a personal choice.

Lynette Ramirez, community member—she brought in Colo.Rev.Stat.15-18.5-101 and read it aloud to the assembly. It will be attached to the minutes.

Brad Roe, fireman/first responder—EMT's, nurses, anyone in the medical profession are being forced by the mandate to take the vaccine or lose their jobs—this is a critical consequence of the vaccine mandate. He would like to see our Elected Officials stand up to this tyranny, to take the necessary steps to stop this violation of our medical care.

Dustin Shedrick, community member—He is a mental health counselor, and feels that the Board should take over the Health Department. He feels that if we have another shutdown, it will adversely affect the community. "There is no justification in the taking away of individual freedoms under the guise of personal safety." Thomas Jefferson

Ginny Lagergren, business owner—She has many concerns and issues with the mandates, for our children and our grandchildren and businesses. She presented the book American Marxism by Mark R. Nevin, reading the first paragraph aloud. She would ask that the Board consider the resolution presented.

Kari Gollihar, army veteran—She fought for our liberty, and she did not serve to be told what to do, but for the opportunity to choose what is best for her family. Vaccines affect people differently, and we should be able to make decisions for ourselves.

Nicki Ehrlich, military family—Over the last 18 to 20 months we have been ignored, manipulated and we have been lied to, to perpetuate fear.

Barb Leininger, community member—She is concerned about what will happen to the animals in feed yards, and the nursing homes on September 30th, when the mandate goes into effect and people have not vaccinated.

Betty Blanco, community member—She feels this is federal overreach to protect vaccinated workers from unvaccinated workers. This should be a choice between the patient and their doctor. It is not the duty of government to determine the rights of the people.

Trudy Hardy, community member—She feels that family/person should be able to decide what the treatment is for that person/family. If we allow the government to make medical decisions it would not be the best decision for us. This is not a Republican issue, not a Democrat issue, this is a human issue, and we cannot allow the government to make our medical decisions.

Chad Penner, community member—announced that Otero County uses Dominion voting machines.

Julie Worley asked if the board would be deciding on the resolution today. The board said they would have a decision at the next board meeting.

Admin. White-Tanabe presented the City of La Junta land donation request decision. This land will be part of the Brick and Tile trail system. Co. Hostetler motioned to approve the land donation. Co. Oquist seconded. Motion carried.

Admin. White-Tanabe presented a Vaccination Mandate Response letter to Governor Polis to waive the mandate due to possible medical crisis with hospital, nursing homes and the like in our county, and the surrounding communities. There were several letters written to attest to this crisis should the mandate be enforced. Admin. White-Tanabe read the letter aloud to the board and guests. Admin. White-Tanabe is asking for signature on the letter. Co. Oquist motioned to approve signature of the letter. Co. Hostetler seconded. Motion carried.

Clerk Lyn Scott presented a security grant to help with election security from the State for \$20,000.00. This grant will allow for new cameras and replacement cameras used in the election process. Co. Oquist motioned to approve sending in the grant paperwork to the State. Co. Hostetler seconded. Motion carried.

Chr. Baldwin asked for approval of bills and payroll. Co. Hostetler motioned to approve bills and payroll. Co. Oquist seconded. Motion carried.

Donna Rohde, DHS Director reported that they are required to have a trust fund set up for the foster children that get social security payments. The bank needs to have permission from the Board for the Treasurer to set that up. Co. Oquist motioned to approve signature for the trust. Co. Hostetler seconded. Motion carried.
Co. Oquist reported that he attended a CCi District meeting in Walsenburg, it was a good meeting, they talked about the legislative meetings. He also attended a SCEDD, they talked about the housing projects in that meeting.

Co. Hostetler attended the RESADA meeting, they	are planning on expanding their building.

Resolution #2021-08

A RESOLUTION OPPOSING COLORADO HEALTH DEPARTMENT MANDATES REQUIRING INDIVIDUALS TO BE VACCINATED FOR COVID-19 AND REQUIRING INDIVIDUALS TO WEAR MASKS IN CERTAIN SITUATIONS.

WHEREAS, on March 18, 2020, the Board of County Commissioners of Otero County declared a local public health and economic emergency resulting from the COVID-19 pandemic, and

WHEREAS, from March 18, 2020, until July 26, 2021, the Board of County Commissioners of Otero County governed Otero County through the recommendations of the Otero County Emergency Manager and the Otero County Health Department Director relative to the local disaster emergency; and

WHEREAS, on July 26, 2021, Resolution #2021-07 was signed resolving that the presence and likelihood of additional causes of the COVID-19 virus within Otero County, Colorado, no longer warranted a declaration of a local public health and economic emergency; and

WHEREAS, every citizen of Otero County who wants a vaccine possesses the right to obtain one, but no vaccine should be mandated by law or required for employment; and

WHEREAS, doctors now have a better understanding of the COVID-19 virus, and the effective treatment options for those who will still acquire the virus; and

WHEREAS, individuals should be allowed to decide for themselves and for their families if they need a vaccination and/or a mask for protection against the virus; and

WHEREAS, the responsibility for one's health and well-being is a personal matter and not something in which the government should be involved; and

WHEREAS, families should be able to decide for themselves what measures they want to take to protect their families from the virus; and

WHEREAS, people have the right to refuse vaccinations based on religious, medical, or personal reasons, and most present-day medical intervention requires informed consent and the right of refusal, including the COVID-19 vaccine; and

WHEREAS, the Board of County Commissioners of Otero County desires to express its opposition to vaccine and mask mandates in both a public and private context and to express its support for the rights of individuals and families living in this jurisdiction to direct their own future health matters.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the County of Otero, Colorado, that:

- 1. The decision to be vaccinated for COVID-19 is an individual and personal decision, and should not be a decision made by force or manipulation by another person or entity or as a condition of employment or activity of any kind.
- 2. The Board desires to express its opposition to COVID-19 vaccine and mask mandates in both a public and private context, and to express its support for the rights of individuals in all health matters.


