Chr. Oquist asked everyone to stand for prayer and to recite the Pledge of Allegiance.

Chr. Oquist called the regular meeting to order.

Chr. Oquist called for approval of the consent agenda. The agenda includes approval of the minutes from September 11th, 2023, and bills and payroll for September 1st, 2023 – September 15th, 2023. Co. Knabenshue motioned to approve the consent agenda. Co. Oquist seconded. Motion carried.

Admin. White-Tanabe presented Resolution #2023-11, a resolution opting into Proposition 123 for the State Affordable Housing Fund. This resolution allows counties and municipalities to apply for funding for affordable housing. Co. Knabenshue motion to approve Resolution #2023-11 opting into Proposition 123. Chr. Oquist seconded. Motion carried.

Admin. White-Tanabe presented Resolution #2023-12, a resolution releasing the Town of Fowler from Promissory Note for the 317 Main St, Fowler, Co. 81039. Co. Knabenshue motioned to approve Resolution #2023-12. Chr. Oquist seconded. Motion carried.

Admin. White-Tanabe presented the Board of Assessment Appeals to appoint Kathryn Schroeder for Special Counsel. Co. Knabenshue motioned to approve Kathryn Schroeder for Special Counsel for the Board of Assessment Appeals. Chr. Oquist seconded. Motion carried.

Admin. White-Tanabe presented Resolution of Participation for the Lower Arkansas Valley Area Agency on Aging Program. This program is for the Year January 1, 2023 – December 31, 2023. The Board of County Commissioners will provide funding in the amount of \$5,846. Co. Knabenshue motioned to approve the 2023 Resolution of Participation. Chr. Oquist seconded. Motion carried.

Admin. White-Tanabe discussed the Sales Tax Report for July 2023 received in September 2023. The total collected was \$219,497.39. This was an increase of .02% compared to July 2022.

Co. Knabenshue attended CCI meetings and discussed new legislation. He also attended the Budget meeting.

Chr. Oquist attended CCI and Budget meetings.

Chief Deputy Casillas reported Lynda Scott and Holly Huerta-Hudak are in Salida for conference. Also, they are preparing for Elections on November 7, 2023.
