Guests in attendance in person: Shawn Mobley, Nancy Harrington, Bette McFarren, and Adrian Hart.

Chr. Oquist asked everyone to stand for Prayer and the Pledge of Allegiance.

Chr. Oquist called the regular meeting to order.

Chr. Oquist called for approval of the consent agenda. The agenda includes approval of the minutes from March 24th and bills and payroll for March 16th through March 31st, 2025. It also included the financial reports from the Department of Human Services. Co. Baldwin motioned to approve the consent agenda. Co. Knabenshue seconded. Motion carried.

Admin. White-Tanabe presented Resolutions 2025-11 and 2025-12. Resolution 2025-11 is Opposing Colorado Senate Bill 2025-3 and Affirming the Constitutional Rights of Otero County Citizens. Resolution 2025-12 is a Resolution Reaffirming Otero County's Stance on the Second Amendment. There was discussion on the two resolutions. Both reaffirm protections given by the U.S. Constitution in the 2nd Amendment. Resolution 2025-11 shows absolute opposition to Senate Bill 2025-3 as it does not address the needs of rural communities or the needs of the citizens of Otero County. Resolution 2025-12 reaffirms the stance of Resolution 2013-07 that was adopted on February 25, 2013, that defends the 2nd Amendment. Sheriff Mobley thanked the Board of Commissioners for Resolution 2025-11 and the Reaffirmation of Resolution 2013-07 in Resolution 2025-12. Sheriff Mobley stated that he believes SB2025-3 to be bad legislation and that local sheriffs opposed its passage. Sheriff Mobley will uphold the Constitution. He feels we need to apply pressure to prosecutors and attorneys to pursue their cases and not go after law abiding citizens.

Co. Knabenshue motioned to approve Resolution 2025-11. Co. Baldwin seconded. Motion carried.

Co. Baldwin motioned to approve Resolution 2025-12. Co. Knabenshue seconded. Motion carried.

Co. Baldwin mentioned that he attended the Southeast Colorado Water Round table. He also attended the voting systems demo with Clear Ballot.

Chr. Oquist and Co. Knabenshue attended several of the same meetings. CCI steering committee, Clear Ballot voting systems demo, Situational Awareness meeting that was held by the former Undersheriff Matt Wallace, and the Southeast Council of Governments. Chr. Oquist also attended a meeting in Trinidad, CO concerning the Pinon Canyon Training depot. Fort Carson will be swearing in a new commander in June. They will be training with drones. The biggest issue at the training site is that there is a Kinder Morgan gas line that runs through the base, and it has hindered the use of some of the property. Admin. White-Tanabe wanted to know if they are thinking of expanding; at this time the answer is no.

Admin. White-Tanabe made the announcements. April 15, 2025, at 2:00 pm will be the ribbon cutting for the new Detention Center and Otero County Offices and Landfill will be closed on April 18, 2025, in observance of Good Friday.

With no further business, the Board adjourned the meeting.


