1. Call to Order: A quorum being present, the meeting was called to order by P. Yoder

b. Approval of Expenditures: K. Lotrich moved to approve the January 2019 and February 2019 expenditures in the amounts of \$129,112.41 and \$132,390.74 respectively, D. Trujillo seconded, motion carried.

## B. Personnel

- a. Positive Feedback
  - ➤ Shurrell Ramsay: On 2/22/2019, Rick received an email from Wendy Larsen, 16th Judicial District Court Executive, which read as follows: "You have stellar employees- Jeff and Rick I wanted to give kudos to two of your staff members. Today, we had a family with unsupervised children who were attending a court proceeding and they were present in the courtroom and then actively exploring around the hallway and restrooms outside my office. Cherell (I hope I have her name correct) is an employee for the Health Department and John Grinstead jumped into action! Somehow Cherell knew that the children had pink eye and she and John when above and beyond cleaning the restroom, the courtroom, drinking fountain, and surrounding areas in the hallway to disinfect surfaces and even the air! John commented that he didn't want any of us getting sick or taking it home to our families! I truly appreciate your employees looking out for us and I appreciate the work that they do every day!"
  - Susan Workman: In early March 2019 an elderly woman became diarrheal and vomited in the courthouse bathroom. Susan took care of the lady, stabilizing her and cleaning her up. Thank you Susan!
- b. New Personnel
  - ➤ Tarren Buford: Mrs. Buford has joined OCHD as a PHN effective 3/11/2019. Her base office will be La Junta. Welcome Mrs. Buford!
- c. Resignation
  - > Jeremy Hill: Mr. Hill has resigned as an AmeriCorps Member.
- d. Status Change
  - > Shurrell Ramsay: Mrs. Ramsay's new base office is Rocky Ford.
- C. Public Health Transformation Steering Committee Co-Chair: R. Ritter has been appointed as the rural Co-Chair of the state-wide Public Health Transformation Steering Committee. Taryn Bailey, El Paso County Public Health, has been appointed as the urban Co-Chair.
- D. Public Health Emergency Law (PHEL) Course: R. Ritter attended an all-day PHEL course in Colorado Springs on 3/5/2019.
- E. CSU Extension Team Award: Our CTC Program has been nominated for the CSU Extension Team Award! This award recognizes the program outcomes and impacts of teams which come together for a specific period of time to work on a special initiative/goal. One or more team members must be a CSU Extension employee.
- F. HB 19-1033: On 1/30/2019, R. Ritter and Rocky Ford Police Chief Angelo Griego traveled to Denver and testified in behalf of HB19-1033, which is entitled "Local Governments May Regulate Nicotine Products" and concerns local governments' authority to regulate products containing nicotine. That day, the bill passed out of committee, it passed out of the House, went to a Senate committee and the full Senate where it passed, and is currently awaiting the Governor's signature to become law. The effective date will be 7/1/2019. M. Mustain and R. Ritter met with the Otero County Commissioners on 3/19/2019, and recommended to the Commissioners to wait until the law becomes effective for taking any public action with the proposed local ordinance.

- G. Bent County Request to Join OCHD STEPP: Bent County Public Health has requested to join OCHD's Regional Tobacco Control Program. Currently, Bent County Public Health has its own STEPP Program and accompanying funding from CDPHE. M. Mustain and R. Ritter have forwarded this request to CDPHE, and CDPHE is working on the administrative processes to accommodate this request. This change would be effective 7/1/2019, and Bent County Public Health's STEPP annual fiscal allocation of \$36,859 would then be transferred to OCHD, and OCHD would be responsible for tobacco control activities in Bent County. This would bring the OCHD's STEPP regional collaborative to nine counties.
- H. Bent County Request to Join OCHD CTC: Bent County Public Health has requested to join OCHD's CTC Program. Bent County Public Health does not currently have its own CTC Program, thus it does not have CTC funding. K. Carpenter is exploring funding options for inclusion of Bent County into OCHD's CTC Program. Potential effective date for this merger is 7/1/2019.
