Chr. Oquist asked everyone to stand for Prayer and the Pledge of Allegiance.

Chr. Oquist called the regular meeting to order.

Diane Remick wanted to address the fact that her son was attacked by a man who lives in a house by the high school that is County even though the road is in the city limits. Her son was taking his friends home when his vehicle was pelted by rocks that were thrown by the gentleman who lives in the home. When her son came back the man was standing in the road with a baseball bat that he hit the vehicle with, shattering the windshield and injuring her son. The police and Sheriff's Office were called. The family and others that live along this road have also had to put up with things being disturbed on their property and things being stolen. Richard Romero also expressed frustration with the situation as it is close to the school and the fact that property keeps being stolen or destroyed.

Kenneth Powell would like to know what can be done about the road near his home on Conejos Rd. There is a junk yard outside his home owned by Mike Gomez, that is not zoned for commercial purposes, it is zoned for residential purposes. He contacted the fire department Chief Brad Davidson, because of candles being burned on the property. It was determined that there are several issues with the property. Mr. Powell is very frustrated with the situation of the road, the trash, and the fact that people keep coming onto his property. Chr. Oquist said that they would be talking to Les Nichols about the situation. Mr. Powell indicated that he had a meeting with Mr. Nichols the next day.

Chr. Oquist thanked them for coming.

Chr. Oquist called for approval of the consent agenda. The agenda includes approval of the minutes from April 28th, 2025, bills and payroll for April 16th through April 30th, 2025, and the Department of Human Services Financial Report, March 31, 2025. Co. Knabenshue motioned to approve the consent agenda. Co. Baldwin seconded. Motion carried.

Donna Rohde, the Department of Human Services Director, presented the Proclamation for the Older American Month for May 2025. This year's theme is "Flip the Script on Aging". In 1925 the average life expectancy was 59 now it is in the 80's and 90's. This year's theme is about a growing understanding that aging is not about slowing down but stepping up! Co. Baldwin motioned to approve signature on the Proclamation. Co. Knabenshue seconded. Motion carried.

Admin. White-Tanabe presented the Fuels Impact Reduction Grant Intergovernmental Agreement for Ratification. The purpose of this agreement is for the Grantee to improve hazardous mitigation corridors in Grantee's jurisdiction in accordance with the State of Colorado Fuels Impact Reduction Grant Program. Co. Knabenshue motioned to approve the ratification. Co. Baldwin seconded. Motion carried.

Admin. White-Tanabe presented the Clear Ballot Agreement. The Clear Ballot Agreement is for new and additional technology, and it has been reviewed by the Commissioner's and the Clerk & Recorders' office. The amount of the agreement is \$234,000.00 over 8 years. Co. Baldwin motioned to approve the agreement. Co. Knabenshue seconded. Motion carried.

Admin. White-Tanabe presented Support for the Southern Colorado Safe Streets and Roads for All (SS4A) Planning Grant letter for Ratification. It will show support for the Southeast Colorado Thriving Communities Program (SECO-TCP) regarding the coordinated regional grant application funding for Safe Streets and Roads for All (SS4A). Co. Knabenshue motioned to approve the letter of support. Co. Baldwin seconded. Motion carried.

Admin. White-Tanabe reported that she has been working with the 2024-11 process and has been meeting with the auditors who have reported that all departments have been very helpful.

Clerk Scott reported that she and Dara Hallman will be attending a mini-recording conference in Canon City, CO in June.

Donna Rohde, Department of Human Services Director, reported that she has been working through the bills that passed and didn't pass through the legislature and what that means for the County in way of cuts or increases of the new regulations.

Co. Knabenshue reported that he had meetings with Colorado Springs Utilities and the Conduit. Met with Rep. Ty Winter and Senator Rod Pelton on legislative bills what passed and what did not.

Chr. Oquist reported that he attended an EMS meeting, and that the courthouse held a lockdown drill. Overall, it went well but there are some things to work on which is why we have them.

Admin. White-Tanabe announced that the courthouse and the landfill would be closed on Memorial Day May 26, 2025, and that the public meeting will be held on May 27<sup>th</sup>, 2025.

### **RESOLUTION #2025-13**

# A RESOLUTION AMENDING THE PERSONNEL MANAGEMENT HANDBOOK.

WHEREAS, on June 30, 2014, the Board of County Commissioners adopted the Personnel Management Handbook; and

WHEREAS, on November 6, 2017, the Board of County Commissioners amended the Personnel Management Handbook; and

WHEREAS, December 23, 2019 the Board of County Commissioners amended the Personnel Management Handbook; and

WHEREAS, the Board of County Commissioners of Otero County desires to amend the Personnel Management Handbook as more fully set forth below;

WHEREAS, in addition to the substantive revisions outlined, other sections of the Personnel Handbook were edited for clarity, consistency, and readability, without making any material changes to the underlying policies;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the County of Otero, Colorado, that:

### The PERSONNEL MANAGEMENT HANDBOOK, is hereby amended as follows:

### 205 INCLEMENT WEATHER

### **DELETE:**

The County rarely closes due to adverse weather conditions... Employees not at work or scheduled to be off when the closure is authorized because they are on leave will have the time charged against their leave accruals as though the office/department had remained open...

### AND REPLACE WITH:

The County rarely closes or delays opening due to adverse weather conditions... Employees who are scheduled to be off or scheduled to work at a location not impacted by the closure are not entitled to closure hours.

### **304 COMPENSATORY TIME**

### **DELETE:**

Compensatory time may be granted at the discretion of the elected official/department head... maximum of one hundred twenty (120) hours...

### AND REPLACE WITH:

Compensatory time is accrued at 1.5 times the overtime hours worked, consistent with FLSA standards. Employees may accrue up to 120 hours... Must be used by January 20 of the following year or paid out. Any unused balance at termination will be paid from the department budget.

### **405 STATUTORY BENEFITS**

### **DELETE:**

Part-time regular/temporary employees are not eligible for medical leave as of January 1, 1994.

### AND REPLACE WITH:

Personnel classified as "part-time" receive all benefits required by Colorado and federal law, including paid medical. . .

### ADD:

Colorado FAMLI Program - Otero County opted out by BOCC Resolution 2022-12 on October 24, 2022; employees may self-enroll and pay their own premiums directly to the State.

### 501 BEREAVEMENT/FUNERAL LEAVE

### DELETE:

...up to two (2) workdays... Immediate family is defined as spouse, brothers, sisters, parents, children, and grandparents, grandchildren and current in-laws...

### AND REPLACE WITH:

Up to four (4) workdays off... for the death of a parent, spouse, child, grandchild, sibling, or current in-law of the same relationship. Up to two (2) workdays off... for the death of a grandparent, niece, nephew, aunt, uncle, or current in-law of the same relationship. Proof of death... should be submitted to the employee's immediate supervisor.

### 506 MEDICAL/SICK LEAVE

### ADD:

Medical leave may also be utilized for:

- Grieve, attend funerals or memorial services, or deal with financial and legal matters related to the death of an immediate family member.
- Care for an immediate family member whose school or place of care has been closed because of inclement weather, loss of power, heating, water, or another unexpected occurrence or event.
- Employees that need to evacuate their residence because of inclement weather, loss of power, heating or water or another unexpected occurrence or event.
- Reasons related to domestic violence, sexual assault, or stalking affecting the employee or a covered family member, including medical care, counseling, legal services, relocation, or safety planning.
- Quarantine or isolation of the employee or a covered family member when so ordered by a health-care provider or public-health authority

### 508 WELLNESS WEDNESDAYS

### ADD:

Otero County supports employee well-being and has established "Wellness Wednesdays" as a voluntary program... Employees may take one 30-minute wellness break each Wednesday... must not be used to shorten the workday... and must be preapproved by the supervisor...

# 510 PUBLIC-HEALTH EMERGENCY (PHE) SUPPLEMENTAL LEAVE ADD:

When a public-health emergency is declared by a federal, state, or local public-health agency, the County will immediately provide up to eighty (80) hours of additional paid medical leave—prorated for part-time employees—for the reasons and during the period required by law. PHE leave is separate from, and does not reduce, an employee's regular medical-leave balance; any unused PHE leave expires four (4) weeks after the official end of the emergency.

### 606 USE OF COUNTY RESOURCES

### ADD:

Any work product, document, program, system, or other intellectual property developed by County employees during work hours or using County resources is considered the property of the County... Unauthorized use, sharing, or transfer... is strictly prohibited.

### 707 TELEPHONES/CELL PHONES

### **DELETE:**

In the interest of good business practice, telephone calls, including those made with cell phones, must be minimal and not interfere with employees' performance of their jobs. Personal use of the County telephones for long distance is not permitted.

### AND REPLACE WITH:

In the interest of good business practice, telephone calls, including those made with cell phones, must be minimal and not interfere with employees' performance of their jobs. Hands-free devices must be used if talking on the phone while driving a vehicle for County business.

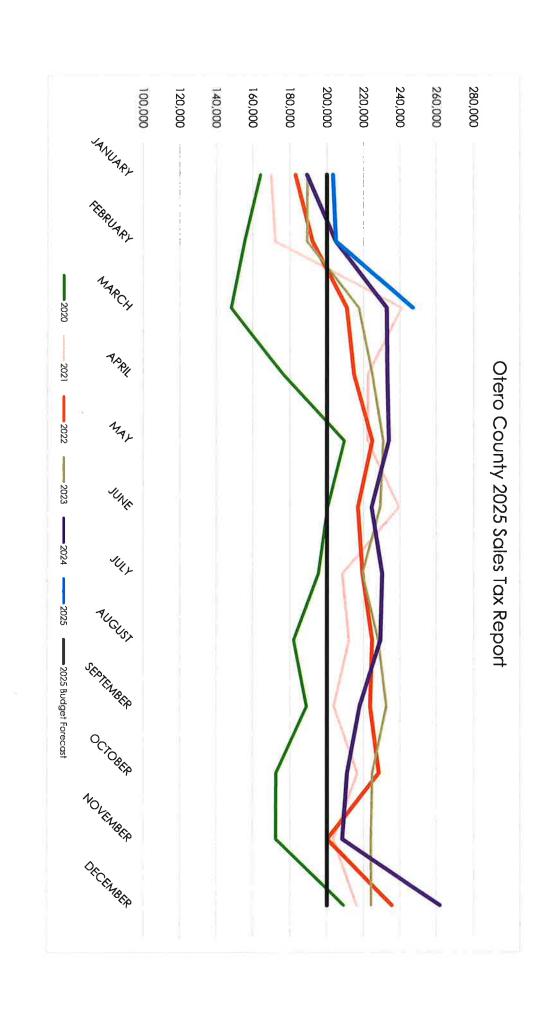
