

Otero County Commissioner Districts

District 1-2 Line

Beginning at the intersection of the south boundary line of Otero County and County Road 25;
thence north along the County Road 25 line to its intersection with the David Canyon Road;
thence northeasterly along the David Canyon Road to its intersection with Colorado Highway 109;
thence northerly along the Colorado Highway 109 line to the point where Colorado Highway 109 becomes County Road 29;
thence continuing north on County Road 29 to a point where County Road 29 becomes San Juan Avenue (within the city limits of La Junta);
thence north along San Juan Avenue to its intersection with the County Road Y line;
thence west along the County Road Y line to its intersection with the County Road 28 line;
thence north along the County Road 28 line to its intersection with the Eighteenth Street line;
thence east along the Eighteenth Street line to its intersection with the Anderson Arroyo;
thence northerly along the Anderson Arroyo to its intersection with Tenth Street in the City of La Junta;
thence east along Tenth Street to its intersection with the Maple Avenue line;
thence south along the Maple Avenue line to its intersection with Fourteenth Street;
thence east along Fourteenth Street to Raton Avenue;
thence north along the Raton Avenue line to the Arkansas River;
thence northwesterly along the Arkansas River to its intersection with the Fort Lyon Canal;
thence easterly along the Fort Lyon Canal to its intersection with the County Road 27 line;
thence north along County Road 27 to the north boundary line of Otero County.

District 2-3 Line

Beginning at the intersection of the west boundary line of Otero County and the Apishapa River;
thence northeasterly along the Apishapa River to its intersection of the County Road V line;
thence east along the County Road V line to its intersection with the County Road 8 line;
thence north along the County Road 8 line to its intersection with the County Road X line;
thence east along the County Road X line to the Rocky Ford Highline Canal;
thence northerly along the Rocky Ford Highline Canal its intersection with Colorado Highway 10;

thence east along Colorado Highway 10 to its intersection with the County Road 18 line;
thence north along the County Road 18 line to its intersection with the County Road EE.25 line (Washington Avenue within the city limits of Rocky Ford);
thence east along Washington Avenue to its intersection with Main Street in the City of Rocky Ford;
thence northeasterly along Main Street to its intersection with Pine Avenue;
thence southeasterly along Pine Avenue to its intersection with Colorado Highway 71 (12th Street within the city limits of Rocky Ford);
thence northeasterly along Colorado Highway 71 (12th Street) to the south R.O.W. line of the Burlington Northern & Santa Fe (BN&SF) Railroad;
thence southeasterly along the BN&SF Railroad to its intersection with the County Road 21 line;
thence north along the County Road 21 line to its intersection with Colorado Highway 266;
thence northeasterly along Colorado Highway 266 to the Arkansas River;
thence southeasterly along the Arkansas River to its intersection with the County Road 22.5 line;
thence north along the County Road 22.5 line to the north boundary line of Otero County.
