Chr. Oquist asked everyone to stand for Prayer and the Pledge of Allegiance.

Donna Rohde, Human Services Director, shared that Gov. Jared Polis proclaimed that the month of August 2024 would be Child Support Awareness Month.

Chr. Oquist called the regular meeting to order.

Chr. Oquist called for approval of the consent agenda. The agenda includes approval of the minutes from August 12, 2024, bills, and payroll for August 1 through August 15, 2024, and approval of Financial Reports-General Human Services, Ending June 30, 2024, and July 31, 2024. Co. Knabenshue motioned to approve the consent agenda. Co. Baldwin seconded. Motion carried.

Timothy Ahopelto with Hinkle & Company presented the 2023 Audit. The audit starts with planning, testing, and reports on operations, they like to get a reasonable understanding of how the County is run, any changes made, and developing a range of information to compare to a range of expectations. There were no corrected adjustments that were needed except for the E911 service. Admin. White-Tanabe mentioned that the audit is on the county website. Overall, the audit was good.

County Treasurer Sharon Jones presented the Semi-Annual report. As of June 30, 2024, the county had \$40,762,467.25 as an ending balance. \$546,305.90 has yet to be disbursed as two school systems have not finished their reports to the State. Co. Baldwin asked about tax income, to date, we have collected \$467,917.92. Last year's total tax income was \$654,525.25 so we are over half of what was collected last year to date. Co. Baldwin motioned to approve the Treasurer's Report. Co. Knabenshue seconded. Motion carried.

Admin. White-Tanabe presented a Secure Transport license and three permits for Med Transport. The Secure Transport license will help patients with behavioral health issues. Co. Baldwin motioned to approve the secure license and the three permits. Co. Knabenshue seconded. Motion carried.

Admin. White-Tanabe presented Resolution 2024-14, A Resolution Authorizing Ground Ambulances in Otero County, Colorado. This will allow all ambulances that are in Otero County and have completed the required permits and licenses by the State to also complete the required permits and licenses in Otero County. The renewals will then run every two years. Co. Knabenshue motioned to approve Resolution 2024-14. Co. Baldwin seconded. Motion carried.

Clerk Scott presented the Intergovernmental Agreement (IGA) for the 2024 General Election. It is an agreement to let everyone know the rules and regulations for the General Election to be held in November. Co. Knabenshue asked if they had to be done yearly. Clerk Scott said ours are perpetual so unless there are changes, they do not. Co. Baldwin motioned to approve the Intergovernmental Agreement. Co. Knabenshue seconded. Motion carried.

Admin. White-Tanabe presented a Contractor agreement between Maverick Solutions and Otero County for services provided to the County for Water Quality Assessments and Solutions. The cost will run about \$3,000.00 per month. Co. Knabenshue motioned to approve the agreement. Co. Baldwin seconded. Motion carried.

Admin. White-Tanabe presented an agreement with DMC Auditing & Consulting. At the last meeting, the Board accepted a bid by them to start in 2024. Co. Baldwin asked where they were located. Admin. White-Tanabe said primarily in Denver, CO. Co. Baldwin motioned to approve the agreement. Co. Knabenshue seconded. Motion carried.

Admin. White-Tanabe presented the sales tax report for June 2024. The county did see about a 2% decline from last month, but we are still on track.

Chr. Oquist and Co. Knabenshue attended many of the same meetings. Two highlights were with Rep. Ty Winter concerning the special session being called about property tax, and the CCI meeting that also mainly revolved around property taxes. Construction meetings for the Detention Center were also at the forefront.

Admin. White-Tanabe announced that the Otero County Offices and the Landfill will be closed on Monday, September 2, 2024, in observance of Labor Day.

With no further business, the Board adjourned the meeting.
