- 1. An accurate drawing suitable for recording prepared by a Colorado licensed land surveyor depicting and legally describing the public street, alley, easement or public way to be vacated, and said drawing shall also note all reservations, if any (unless waived by the Land Use Administrator).
- 2. Verified documentation that the requested vacation will not leave any land adjoining the roadway without an abutting established public road or private access easement connecting the land with another established road.
- 3. A letter from the Fire Department, School District(s), all applicable utility companies and special districts which serve the area in and around the property whose vacation is being sought which shall state the respective authorities' position concerning the proposed vacation (unless waived by the Land Use Administrator).

NOTE:

- 1. Pursuant to Section 4-601 (H), the Land Use Department will prepare the Petition (for Vacation) using the information provided in this Application and the additional information requested above.
- 2. Applicant or a representative is required to be present at the Otero County Commissioner meeting wherein the Petition shall be heard.
- 3. A legal notice referring to the proposed vacation shall be mailed by first-class mail to the last-known address of each landowner who owns one acre or more of land adjacent to the proposed vacated property (or as directed by the Land Use Administrator). Such notice shall indicate the time and place of the County Commissioner meeting and shall indicate that a resolution to vacate the County roadway will be presented at the meeting.
- 4. If applications are not filled out completely, they cannot be processed. All requested information must be submitted at the same time.
